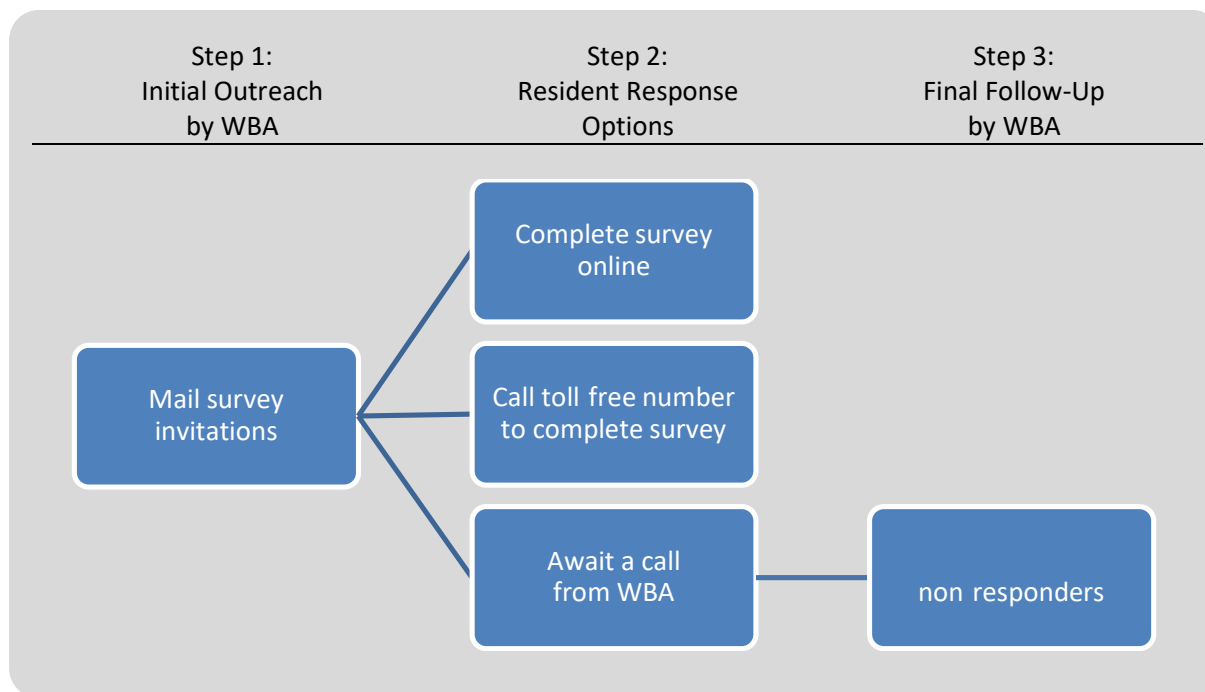

Background, Purpose and Research Approach

Westchester County Parks maintains an 18,000-acre system that includes six public golf courses, swimming pools, beaches, hiking/biking trails, nature preserves, Playland family amusement park and the County Center, an indoor entertainment and civic center. In 2008, the County commissioned a Residents Recreation Preferences Survey. That survey presented information on uses of the County park system, types of recreational activities county residents enjoy and want developed, and what County facilities residents are familiar with and visit. As the County population continues to change in its ethnic and age composition, residents may become interested in different recreational activities, which may require changes in park facilities and capital investment. Additionally, the COVID-19 pandemic has brought a significant increase of use to the park system.

Therefore, in 2022, Westchester County commissioned WBA Research to conduct an updated Residents Recreation Preferences Survey in an effort to respond according to these changes and make strategic investments in maintaining and improving its parks, as well as obtain information from its residents regarding their use of County facilities, what they think about those facilities, and how more residents can be attracted to use County recreational facilities.

In order to gather this information, WBA Research conducted a quantitative study between July 2 and October 3, 2022 using an Address-Based Sampling (ABS) approach, which involved randomly drawing 15,000 addresses of residents throughout the County. Each address was mailed a letter (in English and Spanish) informing them of the Survey. The letter included a link to the online survey and a phone number they could call to schedule a telephone interview. Outbound calling began approximately 3 weeks after letters started arriving at households. To augment this sample, an additional 1,750 addresses in the Southern region of the County were added to the sample.



Background, Purpose and Research Approach (continued)

From this survey approach, WBA collected 792 completed interviews among Westchester County Residents, broken out by County region and gender as outlined in the table below. In order to more accurately represent the region and gender populations in the County, the data were weighted using data from the 2021 release of the U.S. Census Bureau's American Community Survey.

The regions were defined by zip code of residence and are shown overlaid on the parks and recreation facility map on the next page.

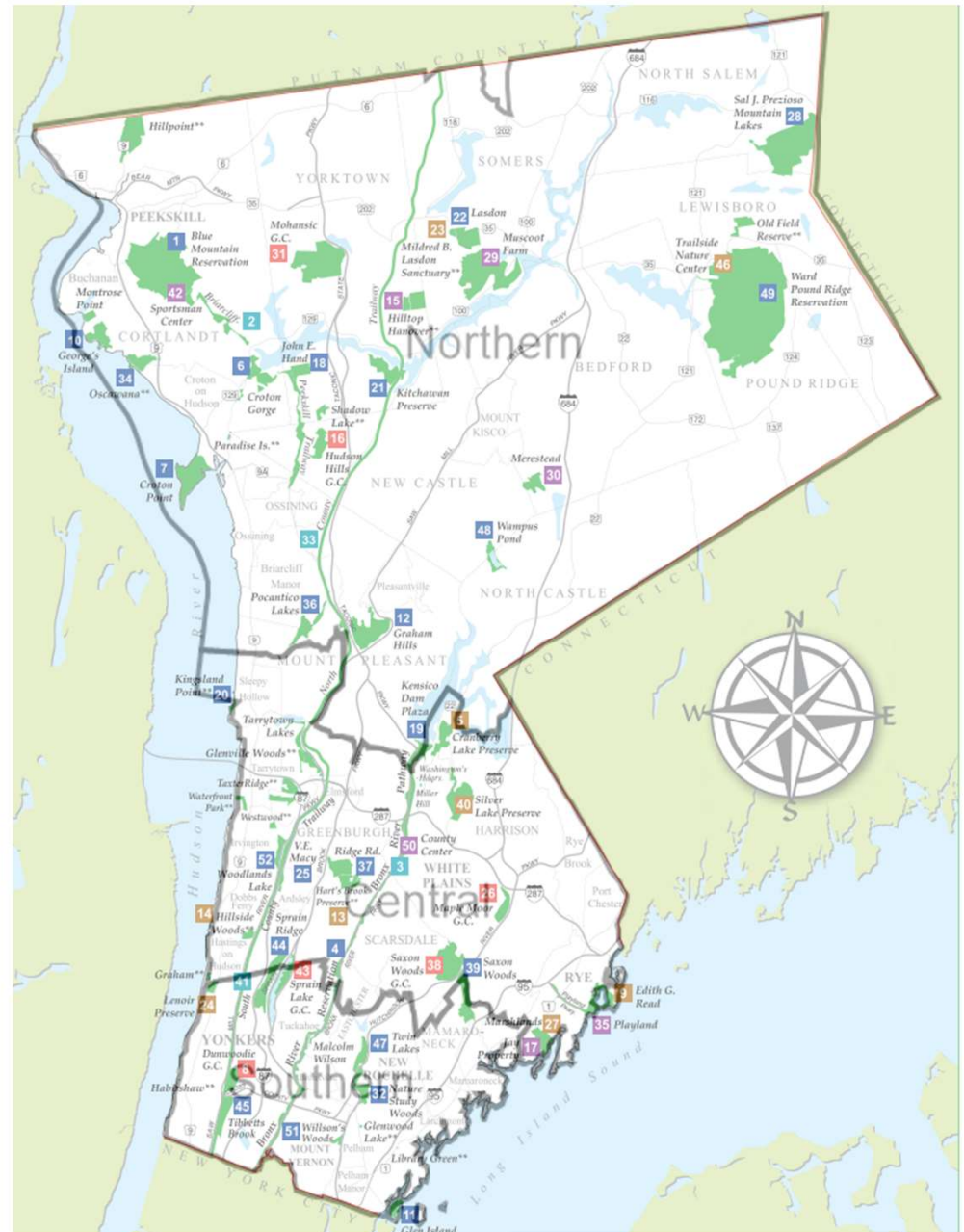

Standard Error of the Data

Because in research the entire population is typically not interviewed, but rather a sample of that population is surveyed, the data are subject to sampling error. The maximum sampling error for the Total Sample of 792 interviews is ± 3.5 percentage points at the 95% confidence level. However, the actual standard error may be smaller, depending on the data being examined.

For example, if a question in the study asked among the Total Sample of respondents yielded a percentage of 20%, then we can be sure 95 out of 100 times that the true percentage would lie between 17.2% and 22.8% (20% ± 2.8 percentage points).

Notes on Reading the Report

Significant differences are shown, when applicable, through the use of letters (e.g. B vs. D) for comparisons between Respondent Region of Residence.

- For example, if a percentage of residents answering from the Northern region of Westchester County (B) is significantly higher than the percentage of those answering from Southern Westchester County (D), there will be a “D” next to the higher North County percentage.

Where applicable, the 2022 survey data is compared to data collected in 2008. Significant changes from 2008 to 2022 are shown through the use of arrows (\uparrow , \downarrow) next to the 2022 percentage.

- For example, if a measure has significantly increased from 2008 to 2022, there will be a \uparrow next to the 2022 percentage.

Executive Summary

Background, Purpose and Methodology

Westchester County Parks, Recreation and Conservation commissioned WBA Research to conduct a Residents Recreation Preferences Survey to support strategic investments in maintaining and improving its parks, as well as obtain information from its residents regarding their use of County facilities, what they think about those facilities, and how more residents can be attracted to use County recreational facilities. In order to gather this information, WBA Research conducted a quantitative study between July 2 and October 3, 2022 using an Address-Based Sampling (ABS) approach, which resulted in a total of 792 completed interviews stratified across the three regions of the County.

Key Findings

Effect of the COVID-19 Pandemic

The results of this research suggest that the COVID-19 pandemic prompted a net increase in use of Westchester County parks and recreation facilities that many residents intend to maintain, especially those in the North and Central regions of the County. While close to one-fourth of County residents (23%) indicated their use of County parks and recreation facilities decreased during this time, an even greater proportion (43%) cited increased use. Likewise, the proportion who intend to maintain their increased use of Westchester County parks and recreation facilities is more than five times that of those who plan to maintain a post-pandemic decrease (37% vs. 7%). In addition, increased use of County parks and recreation facilities is evident throughout this report when comparing the 2022 data to the findings of the 2008 Residents Recreation Preferences Survey.

Usage of County Parks and Facilities

Several measures in this study indicate that the top benefit County residents see as being provided by Westchester County parks and recreation facilities are the walking, hiking, and biking trails. Residents cite these trails most often as a need from Westchester County parks (88%), they receive the highest ratings for being the most important type of parks and recreation facilities they want Westchester County to provide (76%), and more than eight in ten (83%) have used these trails in the past 12 months.

Among all parks and facilities, Kensico Dam Plaza (54%), Playland Park (45%), Bronx River Parkway Reservation/Pathway (39%), Westchester County Center* (38%), Muscoot Farm (33%), Saxon Woods Park/Pool (32%), Glen Island Park/Beach (32%), Croton Point Park/Beach (29%), and North County Trailway (22%) are the parks and recreation facilities visited by the largest proportions of residents in the past 12 months.

* Regarding Westchester County Center, this facility has served as a field hospital for administering COVID-19 vaccinations over the past few years. When asked, the residents surveyed in 2022 most often said they would like to see concerts return to the venue (76%), followed by family entertainment (56%), recreational events (44%), and professional sporting events (41%).

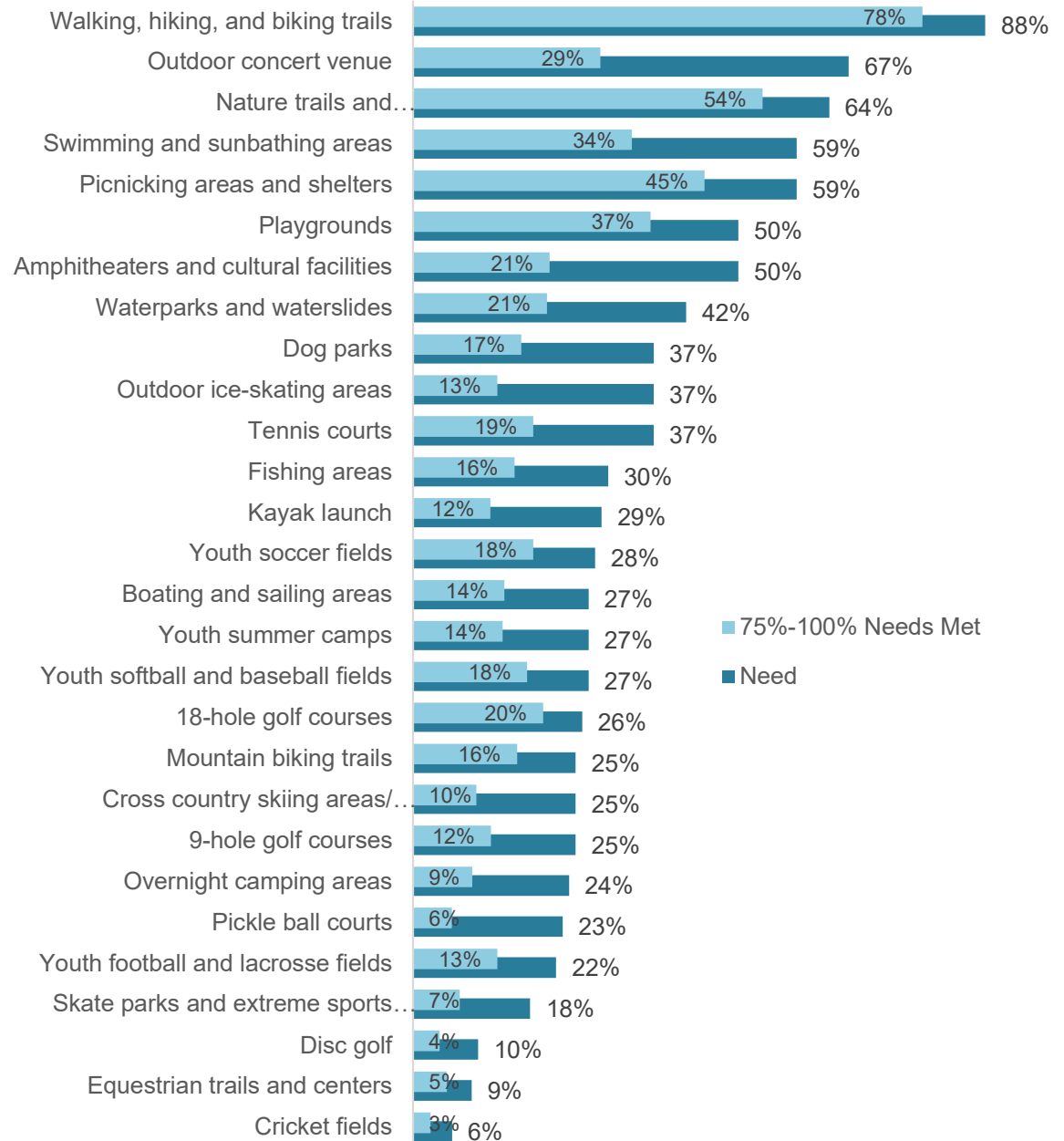
Meeting the Needs of County Residents

The chart to the right illustrates County residents' reported needs in term of parks and recreation facilities in Westchester County, as well the proportion who feel those needs are being mostly to completely met (75%-100% met).

Walking, hiking, and biking trails tops the list of reported needs (88%). At the same time, the majority of these residents also indicated this need is mostly to completely being met by Westchester County parks.

Nature trails and nature interpretive centers represent another top need of County residents (64%) where Westchester County parks and recreation facilities are also filling a significant proportion of the need.

In contrast, any areas where there is a large gap between the reported need and the proportion of the need being mostly or completely met represents an opportunity for Westchester County to potentially improve. For example, two-thirds of the County residents surveyed (67%) indicated the need for an outdoor concert venue. However, the proportion indicating this need is being mostly or completely met is comparatively low.



Impressions/Benefits of Parks and Recreation Facilities

The results of this research show that the majority of Westchester County residents value the parks and recreation facilities in available to them and recognize many of the benefits they offer.

- Eight in ten residents surveyed in 2022 indicated they are satisfied with the overall value their household receives from Westchester County Department of Parks, Recreation, and Conservation (80% very or somewhat satisfied, up from 67% in 2008).
- In addition, many benefits are clear. Almost all residents surveyed agree that improving physical health and fitness (97%), preserving open space and the environment (96%), making Westchester County a more desirable place to live (95%), and improving mental health and reducing stress (95%) are all benefits of the parks and recreation facilities. The vast majority feel the most important benefit is improving physical health and fitness (86%).
- More than nine in ten residents (91%) have positive impressions of the physical condition of the parks and recreation sites they have visited in Westchester County (up from 84% in 2008). However, most of these ratings are in the “good” category (65%), while about one-fourth (26%) gave a rating of excellent, suggesting there is still room for improvement. In fact, about one-fourth indicated poor maintenance of the facilities (27%) and/or parks (23%) might prevent them from using the parks, trails, recreations facilities, and programs more often.
- When tasked with investing \$100 in funds in the Westchester County Park System over seven possible categories, the residents were most likely to allocate funds to improvements and maintenance of existing Westchester County parks (75%), further suggesting there is room to improve in this area. On average, these residents would allocate the largest sums to improvements and maintenance of existing Westchester County parks (\$26.86 out of \$100), followed by an almost even division of funds among Development of new trails and pathways, i.e., walking, hiking and biking trails, etc. (\$15.91), development of water-based recreation, i.e., swimming facilities, boating and fishing areas, beaches, etc. (\$15.38), and acquisition of new parkland and open space (\$13.89).

Keeping County Residents Informed

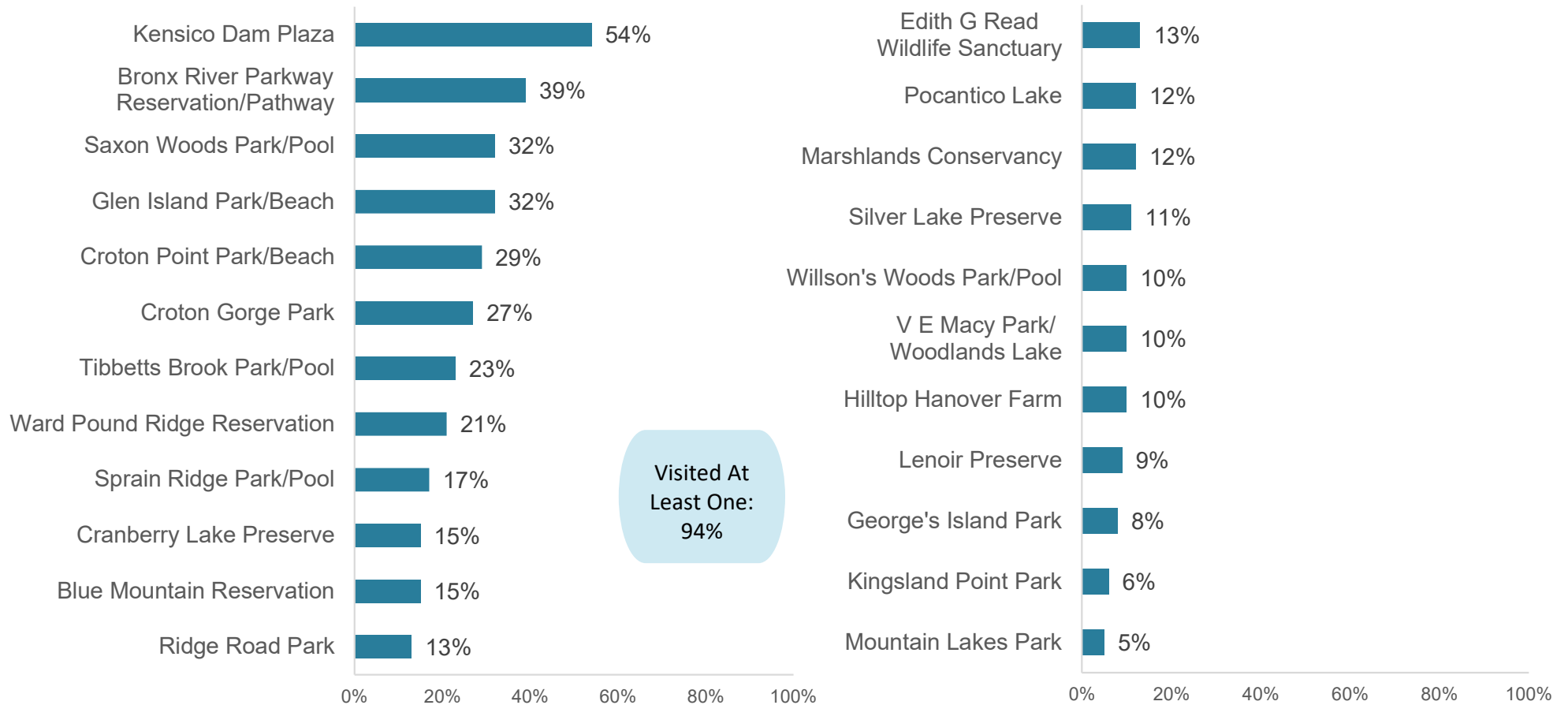
This research suggests that one of the biggest issues that might prevent residents from using parks, trails, recreation facilities, or programs of the Westchester County Department of Parks, Recreation and Conservation more often, is a basic lack of information. One-half (50%) of the residents surveyed indicated they have a lack of knowledge including not knowing what is being offered (45%), not knowing the locations of parks and facilities (31%), and/or not being aware which are County parks (29%). These represent an opportunity for the County to better inform residents.

- The residents surveyed most often said they learn about Westchester County Department of Parks, Recreation, and Conservation programs and activities from friends and neighbors (79%) and/or the Parks website (65%), followed by Parks literature (44%), online news articles (44%), and or social media (43%) – typically Facebook (33%) and/or Instagram (21%). These sources may be of assistance with filling in residents' knowledge gaps.

Detailed Findings

Westchester County Parks Visited, Past 12 Months

The vast majority of Westchester County residents surveyed in 2022 (94%) have visited at least one County park in the past 12 months, most often citing Kensico Dam Plaza (54%), followed by Bronx River Parkway Reservation/Pathway (39%), Saxon Woods Park/Pool (32%), Glen Island Park/Beach (32%), Croton Point Park/Beach (29%), and/or Croton Gorge Park (27%).

Residents of Northern Westchester County were most likely to have visited Croton Point Park/Beach (53%), Croton Gorge Park (47%), Kensico Dam Plaza (46%), Ward Pound Ridge Reservation (36%) and/or Blue Mountain Reservation (32%).

Central region residents were mostly likely to have visited Kensico Dam Plaza (70%), Bronx River Parkway Reservation/Pathway (50%), and/or Saxon Woods Park/Pool (39%).

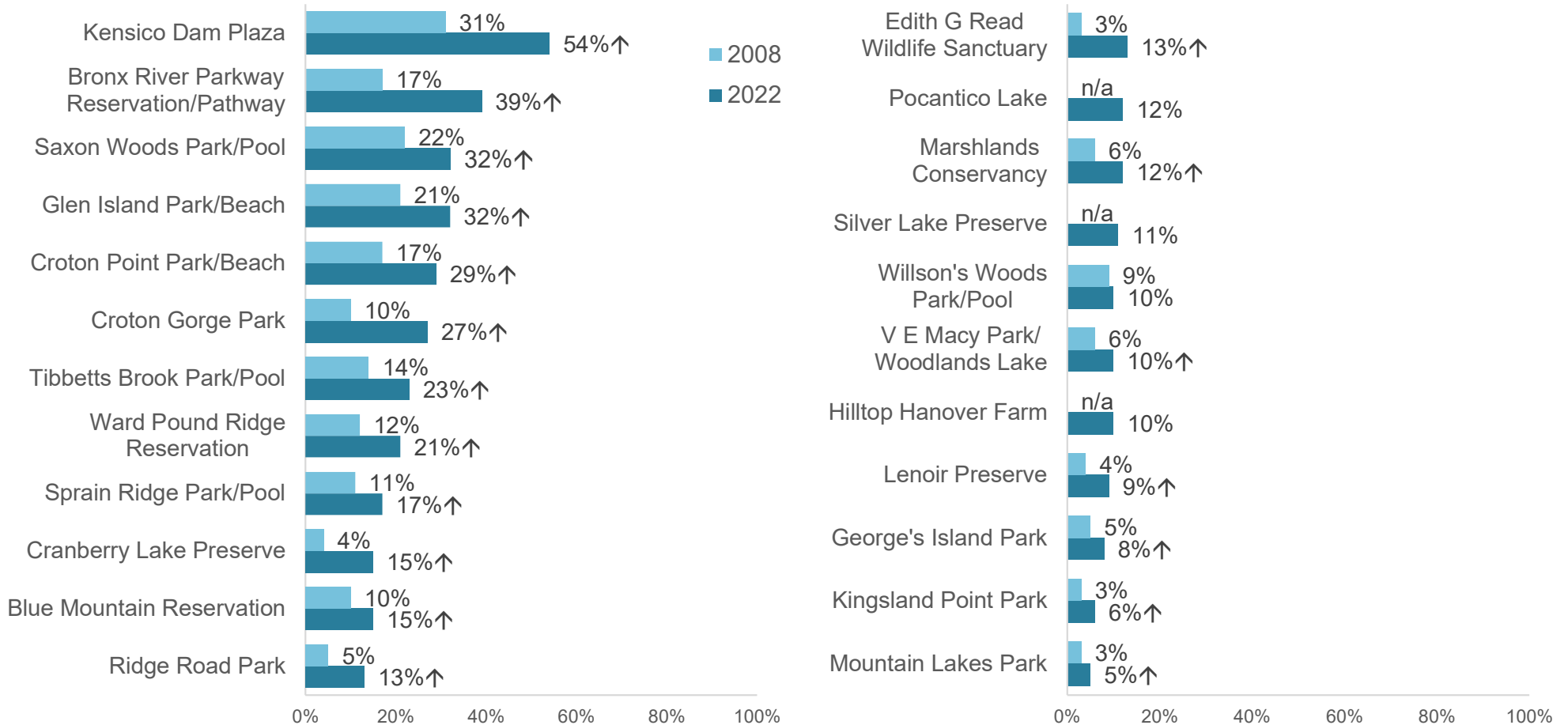

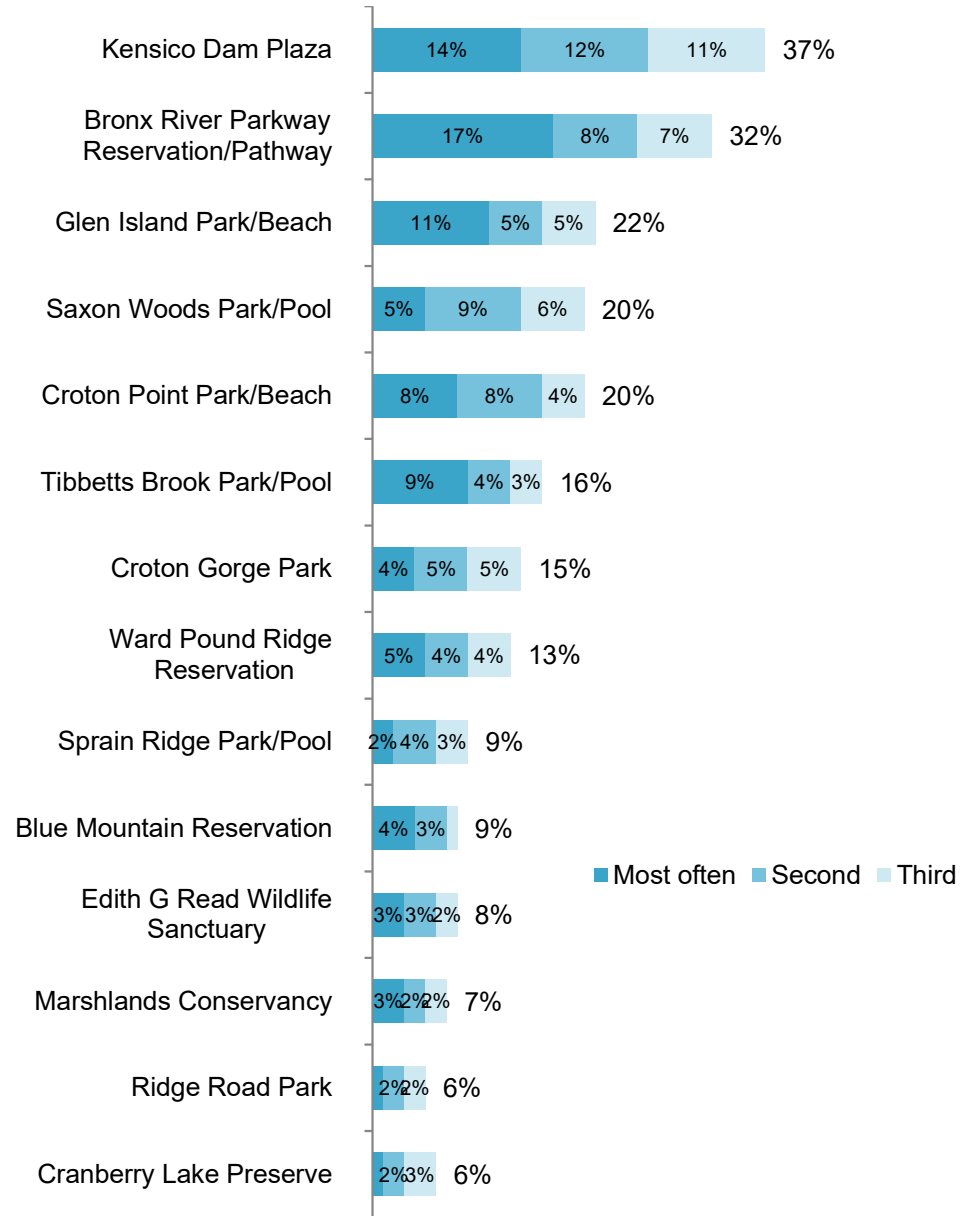

Westchester County Parks Visit Most Often

Those who have visited at least one Westchester County park in the past 12 months (94% of the residents surveyed) were asked which one they visit most often, second most often, and third most often.

These County residents reported most often visiting Kensico Dam Plaza (37%) and/or Bronx River Parkway Reservation/Pathway (32%), followed by Glen Island Park/Beach (22%), Saxon Woods Park/Pool (20%), and Croton Point Park/Beach (20%).

Residents of Northern Westchester County were most likely to say they visit the following parks most often: Croton Point Park/Beach (48%), Croton Gorge Park (36%), Kensico Dam Plaza (33%), Ward Pound Ridge Reservation (27%) and/or Blue Mountain Reservation (25%).

Those in Central Westchester County were most likely to say they visit Kensico Dam Plaza most often (60%), followed by Bronx River Parkway Reservation/Pathway (43%), and Saxon Woods Park/Pool (28%).

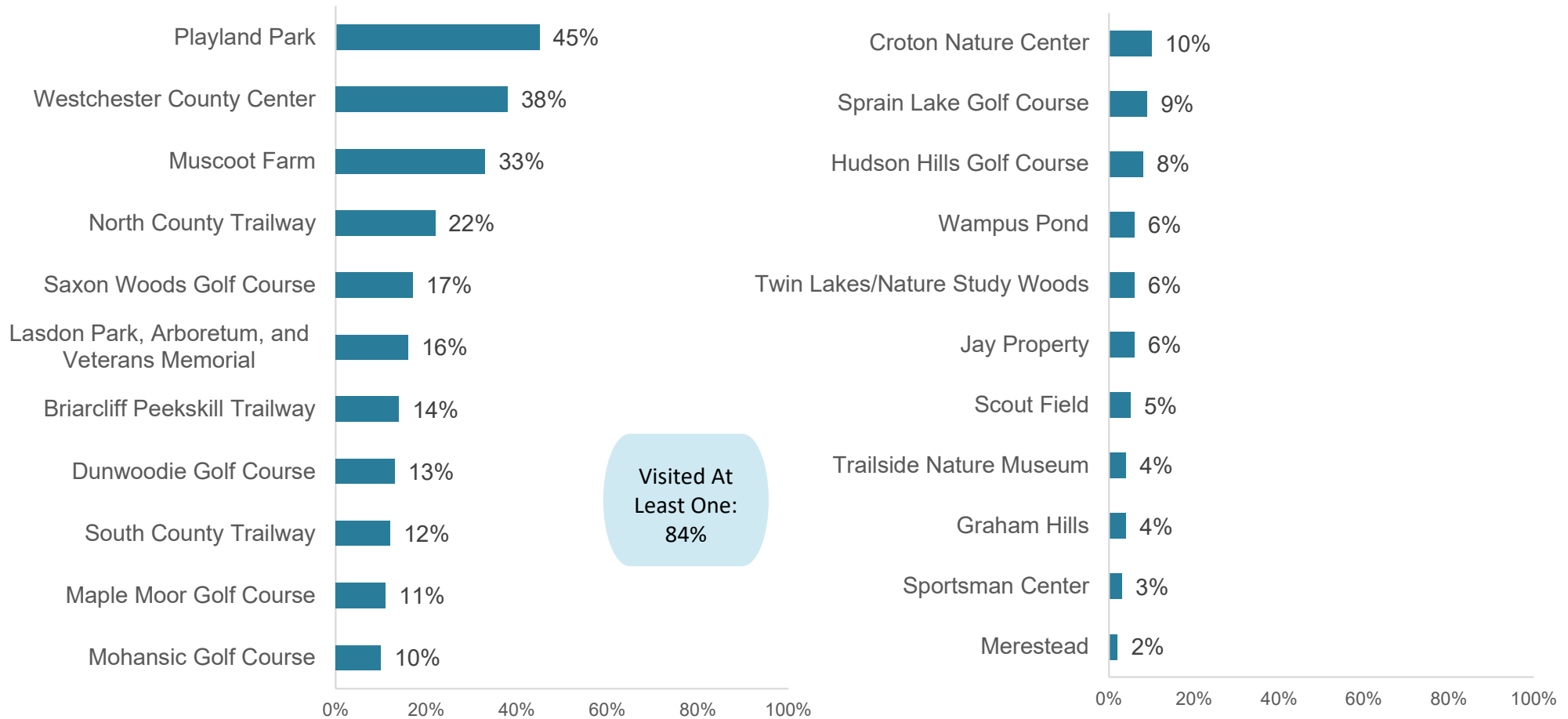

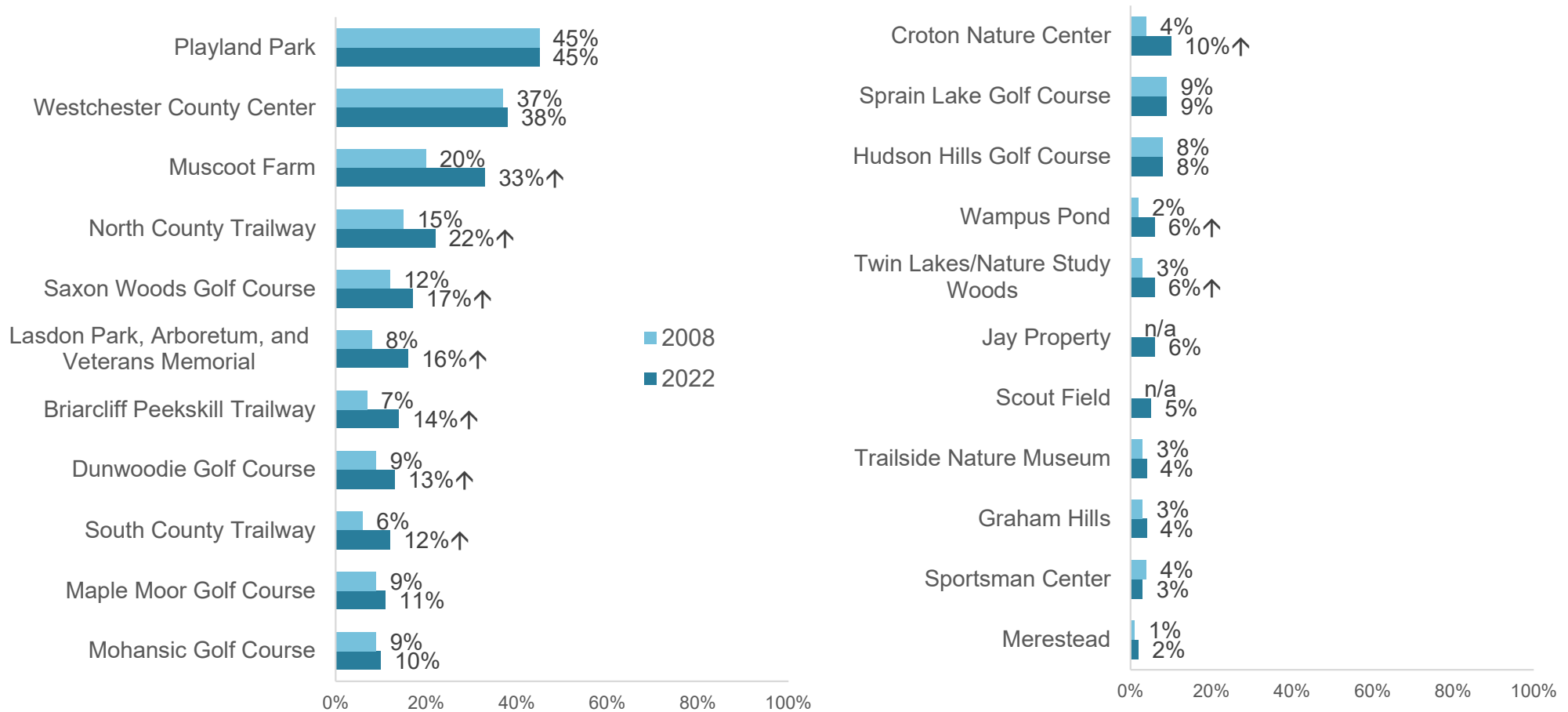

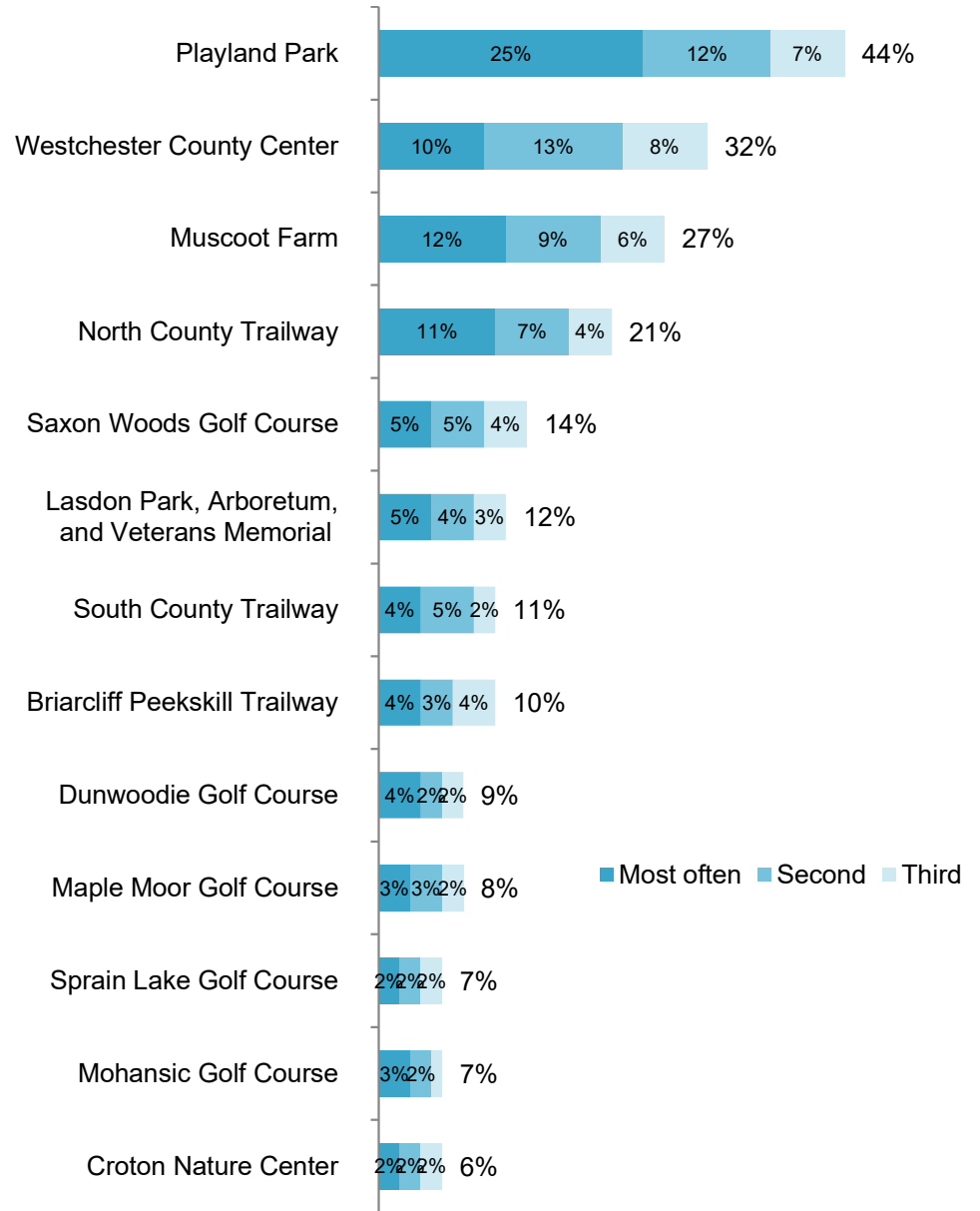

Westchester County Recreation Facilities Visit Most Often

Those who have visited at least one Westchester County recreation facility in the past 12 months were asked which one they visit most often, second most often, and third most often.

The County residents surveyed in 2022 reported most often visiting Playland Park (44%), followed by Westchester County Center (32%), Muscoot Farm (27%), and North County Trailway (21%).

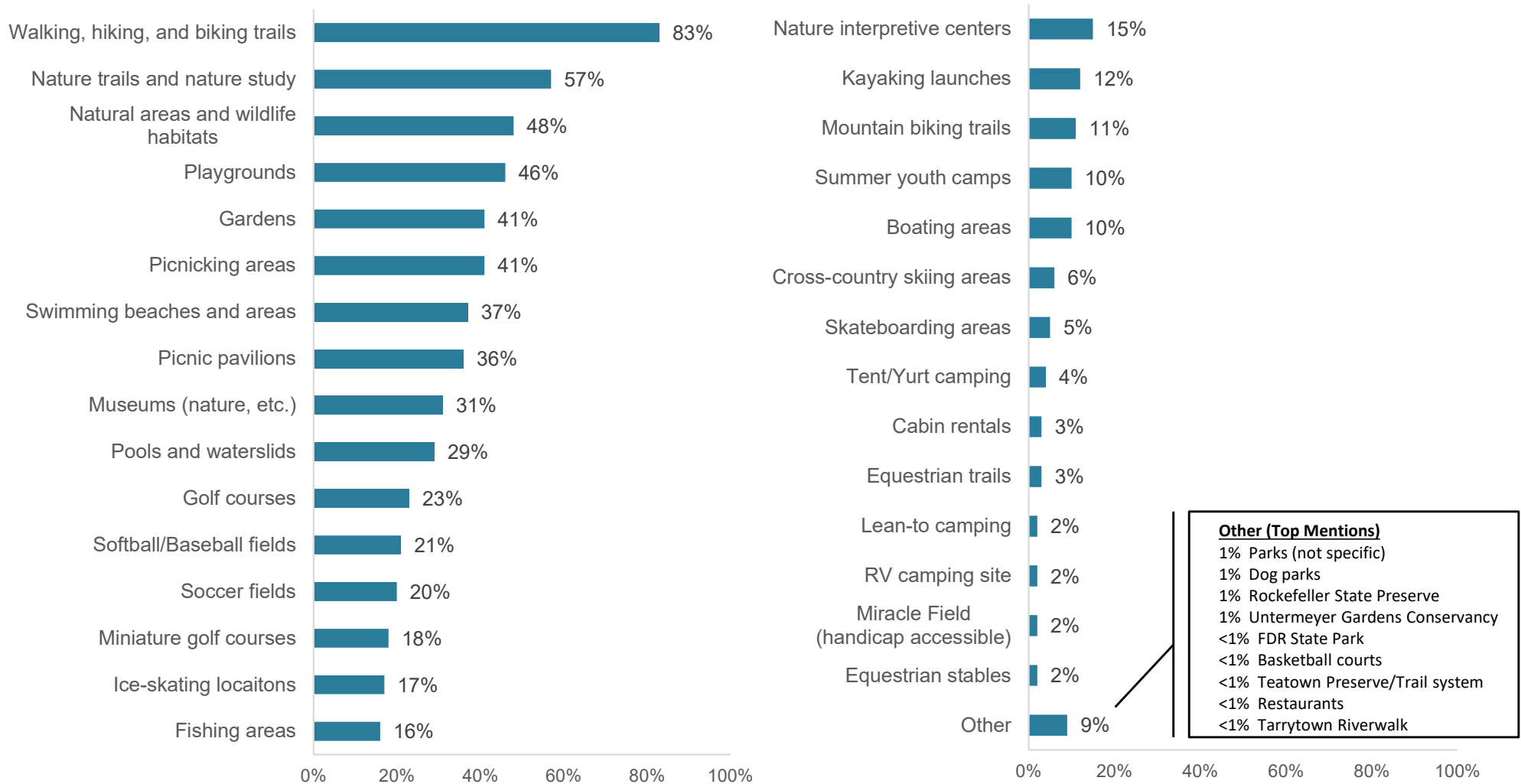

The residents surveyed in 2022 were presented a list of 30 types of Westchester County parks and recreation facilities and were asked to indicate all those they have visited or used over the past 12 months. More than eight in ten County residents have used walking, hiking and biking trails in Westchester County over the past 12 months (83%). Other parks and facilities selected most often included nature trails and nature study (57%), natural areas and wildlife habitats (48%), playgrounds (46%), gardens (41%), picnicking areas (41%), swimming beaches and areas (37%), and/or picnic pavilions (36%).

While residents across all three regions of the County were most likely to have visited or used walking, hiking and biking trails, those in the Southern region were the least likely of the three regions to have done so (78% vs. 85%-89%).

Some of the biggest differences by County region are found when comparing residents of the Southern region to the rest of the County. These residents tended to be the most likely to have used playgrounds (54%), swimming beaches and areas (47%), picnicking areas (46%), pools and waterslides (39%), softball/baseball fields (27%), soccer fields (23%), ice-skating locations (21%), and/or lean-to camping (4%).

On the other hand, residents of the Northern region of the County tended to be the most likely to have used nature trails and nature study (65%), natural areas and wildlife habitats (54%), and/or fishing areas (20%).

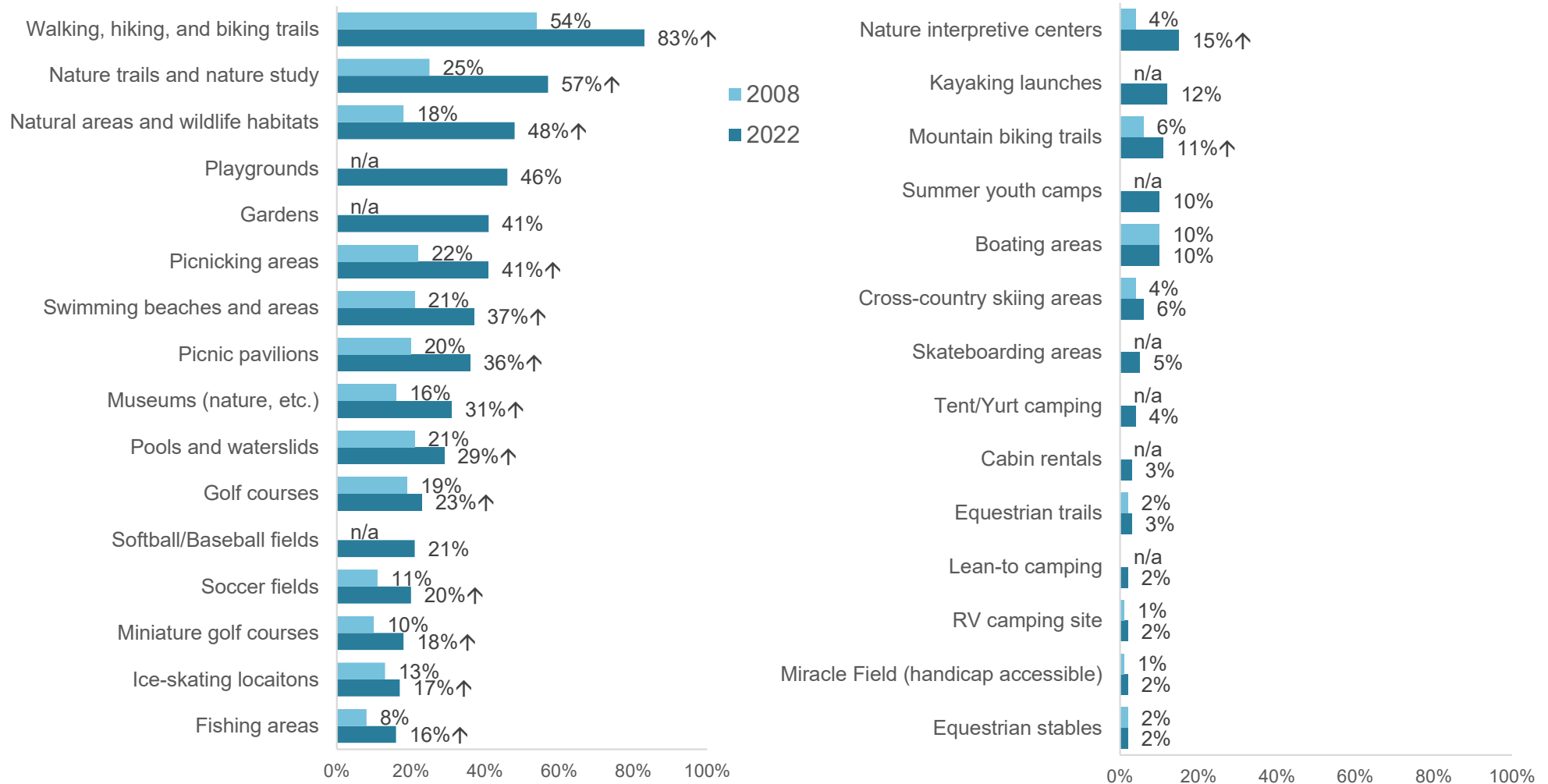

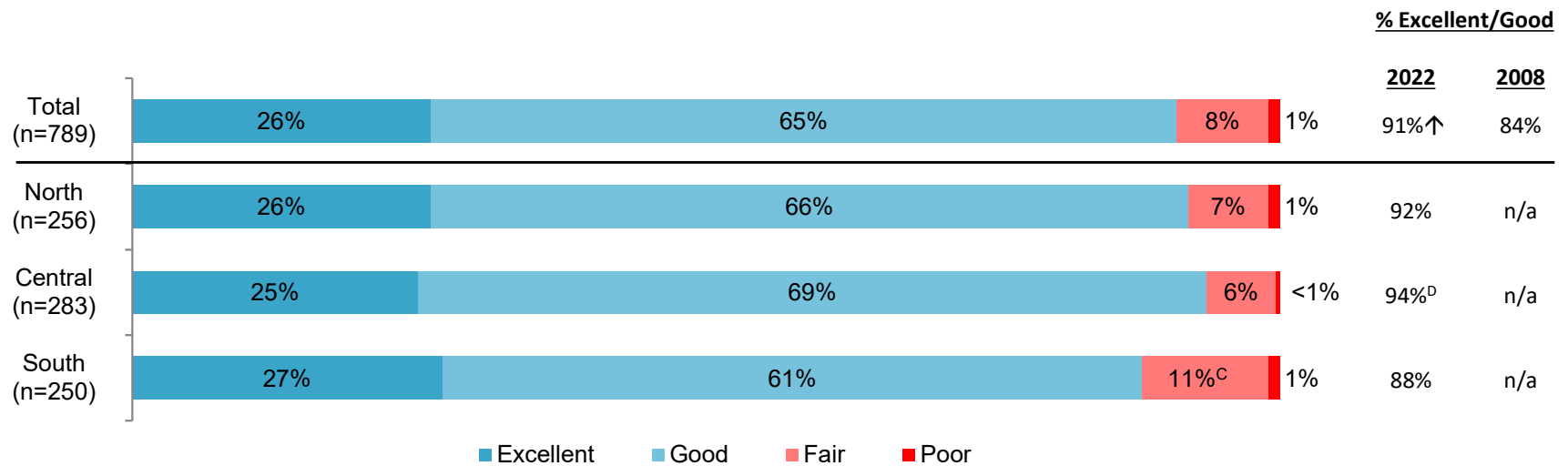

Physical Condition of Westchester County Parks and Recreation Sites

When asked to rate the physical condition of all the parks and recreation sites in the Westchester County parks and recreation areas they have visited, more than nine in ten residents surveyed in 2022 (91%) gave a rating of excellent or good (up from 84% in 2008). Most of these positive ratings, however, are in the “good” category (65%), with about one-fourth (26%) giving a rating of excellent.

By region, residents of Central Westchester County tended to be the most likely to give positive ratings of excellent or good (94%), while those in the Southern area were least likely (88%).

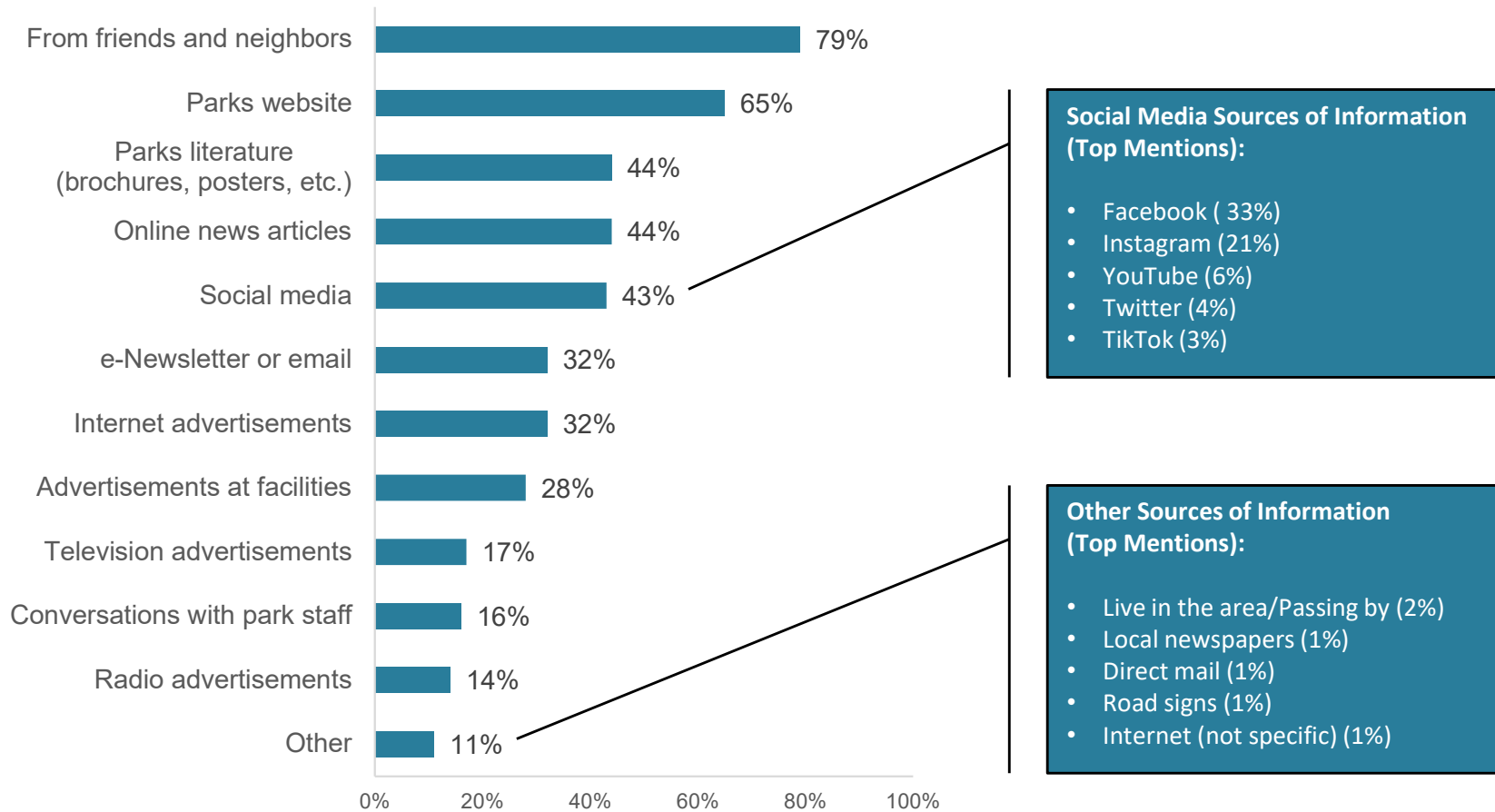
Q6. Overall, how would you rate the physical condition of all the parks and recreation sites in the Westchester County parks and recreation areas you have visited?

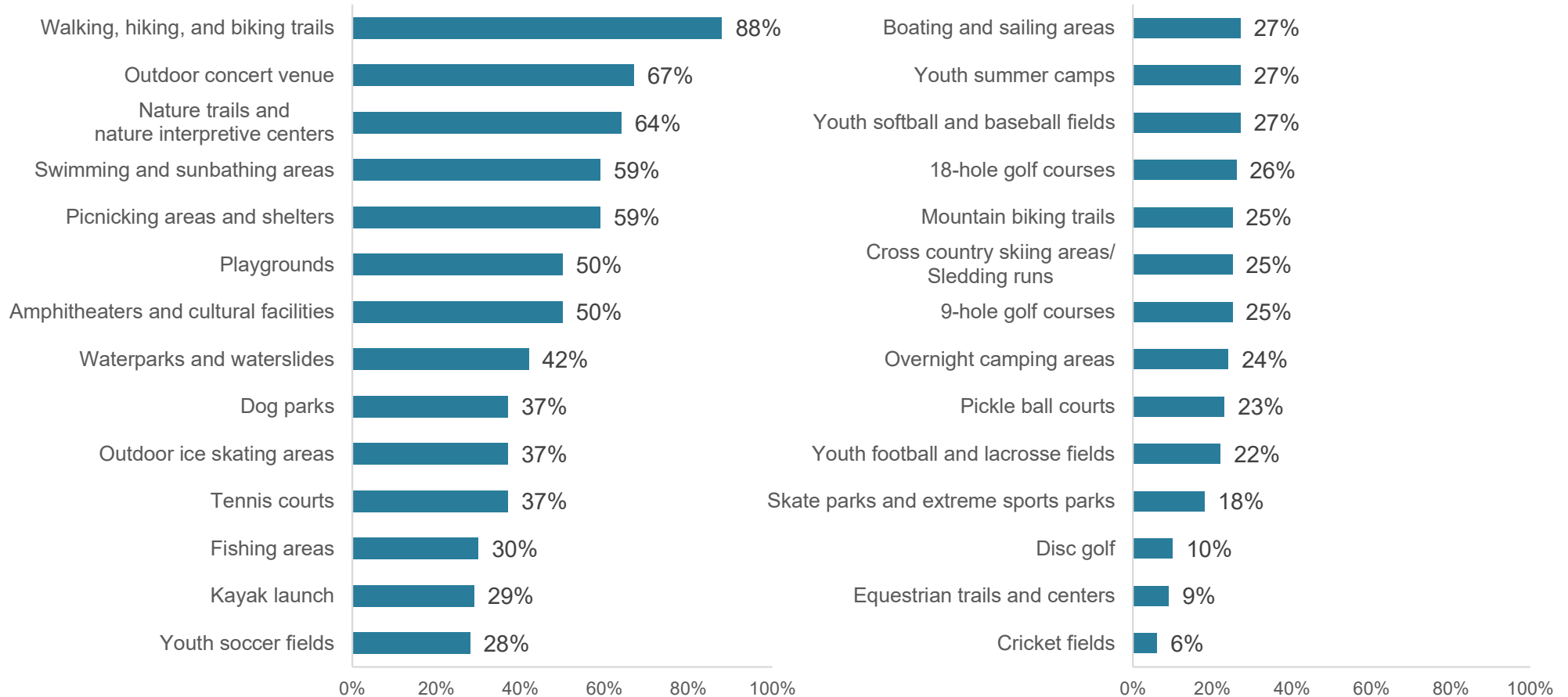
Q7. In which of the following ways do you learn about Westchester County Department of Parks, Recreation, and Conservation Programs and Activities?

Types of Parks/Recreation Facilities Needed

From a list of 28 types of parks and recreation facilities, the vast majority of residents surveyed indicated that they or members of their household have a need for walking, hiking, and biking trails (88%). In addition, at least one-half indicated a need for an outdoor concert venue (67%), nature trails and nature interpretive centers (64%), swimming and sunbathing areas (59%), picnicking areas and shelters (59%), playgrounds (50%), and/or amphitheaters and cultural facilities (50%).

When asked if there are any other types of parks or recreational facilities that they or a member of their household has a need for very few cited any one specific thing, but the most frequent response was ADA accessible parks and facilities (1%).

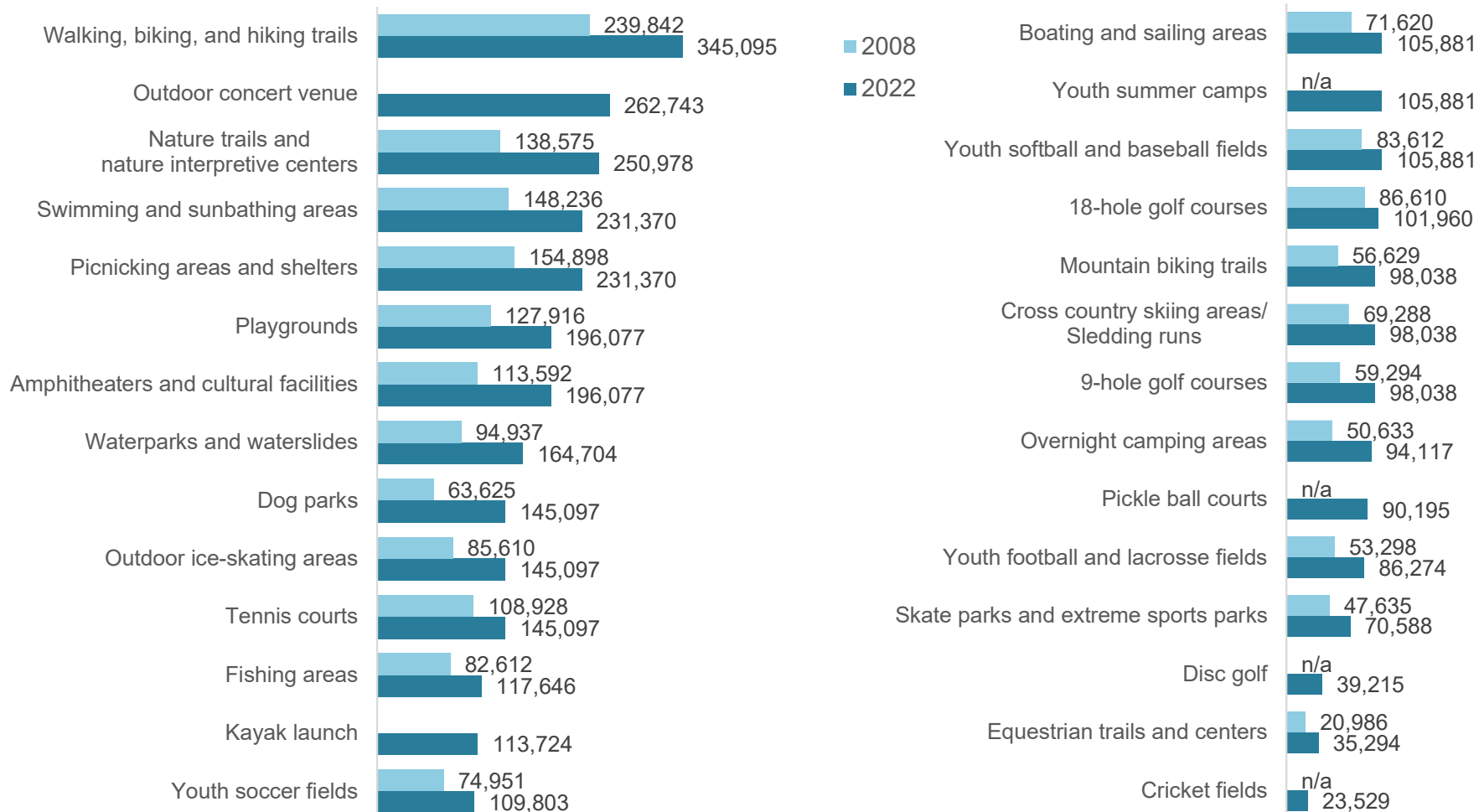

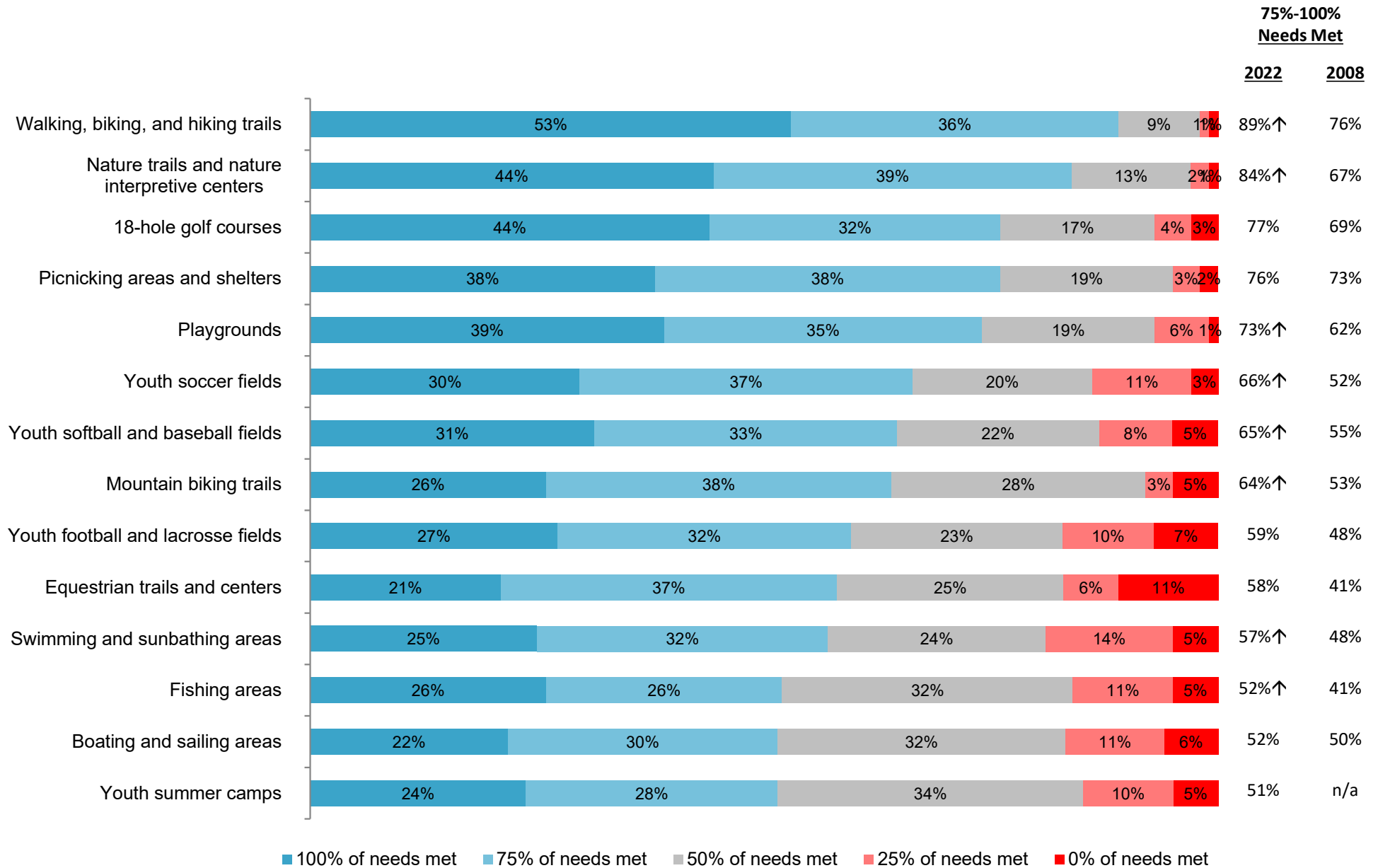
How Well Parks and Recreation Facilities Meet Needs

Residents who indicated a need for each of the 28 types of parks and recreation facilities were then asked to rate how well these types of parks and recreation facilities in Westchester County are meeting their needs.

The highest rated parks and recreation facilities with residents indicating between 75% and 100% of their needs are being met by Westchester County include: walking, hiking and biking trails (89%, up from 76% in 2008), nature trails and nature interpretive centers (84%, up from 67%), 18-hole golf courses (77%), picnicking areas and shelters (76%), and playgrounds (73%, up from 62%).

Even the parks and facilities with the lowest ratings for meeting residents' needs in 2022 showed improvements if they had been rated in 2008, including skate parks and extreme sports parks (up from 31% to 40%), cross-country skiing areas/sledding runs (up from 29% to 39%), overnight camping areas (up from 30% to 38%), and outdoor ice-skating areas (up from 30% to 35%). The lowest rated facilities in terms of meeting residents' needs in 2022 are pickle ball courts (26%).

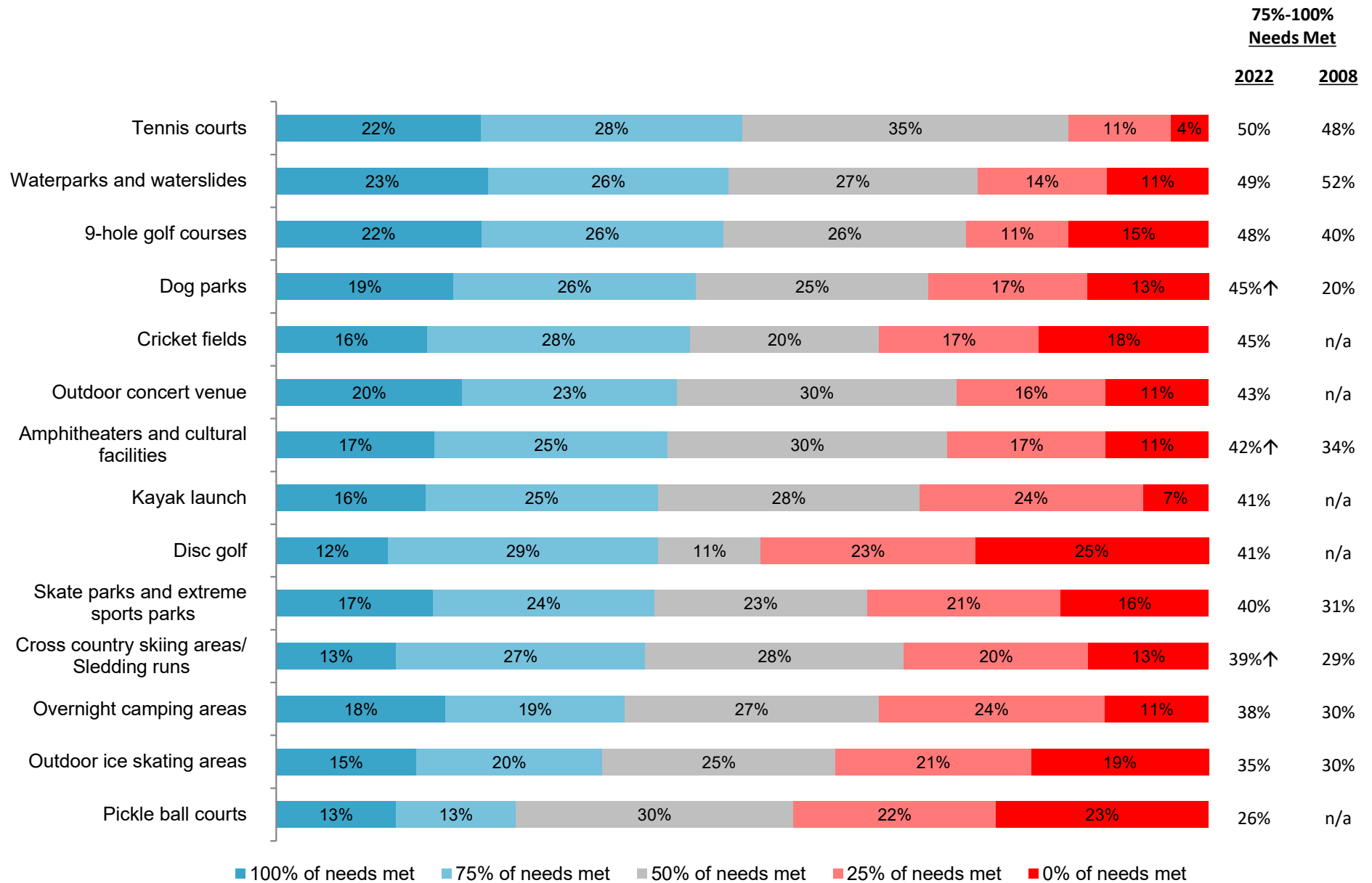

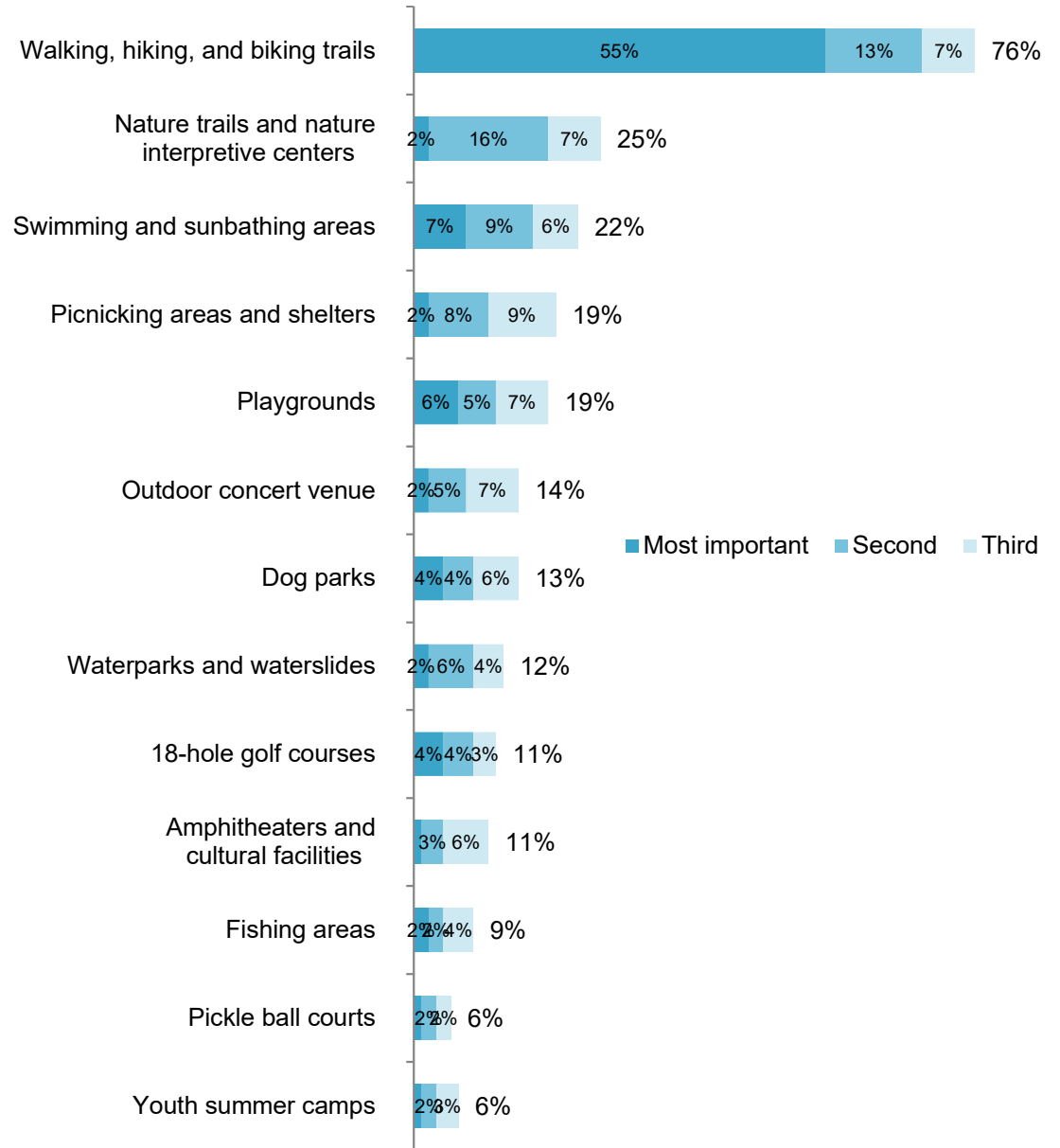

Benefits of Park and Recreation Facilities

The County residents surveyed were asked to rate their agreement with 10 different benefits being provided by parks, trails, recreation facilities, and services in Westchester County. Overall, there are four benefits that almost all residents agree are provided:

- Improves physical health and fitness (97%),
- Preserves open space and the environment (96%),
- Makes Westchester County a more desirable place to live (95%), and
- Improves mental health and reduces stress (95%).

In fact, about seven in ten or more strongly agree that each of these are benefits of Westchester County parks, trails, recreations facilities and services (69%-78%).

At least three-fourths of the residents surveyed agree that each of the following is a benefit provided by Westchester County parks, trails, recreations facilities and services:

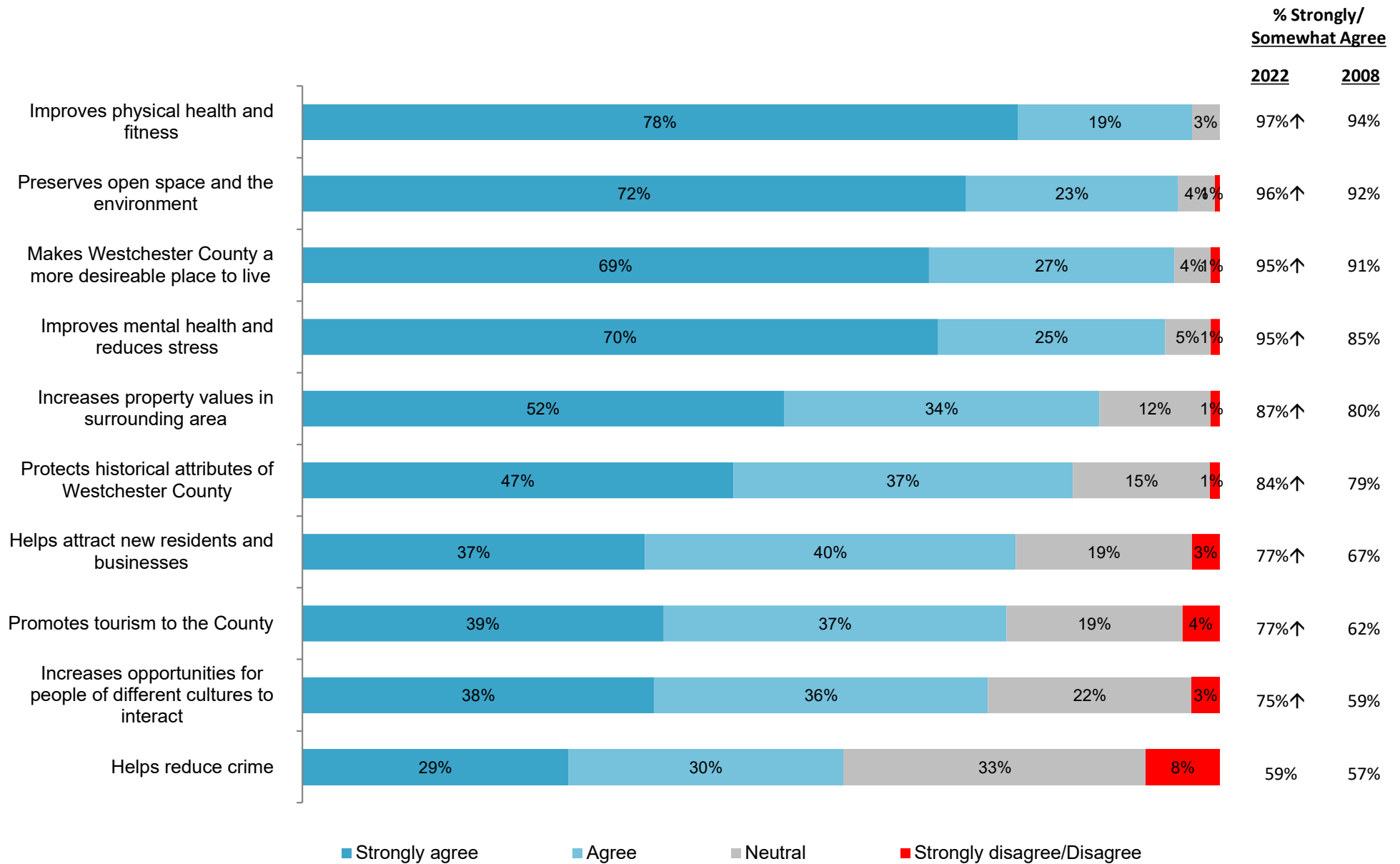
- Increases property values in the surrounding area (87%),
- Protects historical attributes of Westchester County (84%),
- Helps attract new residents and businesses (77%),
- Promotes tourism to the County (77%), and
- Increases opportunities for people of different cultures to interact (75%).

Compared to 2008, agreement with these benefit statements has increased in 2022.

While residents are least likely to agree that the parks and facilities help reduce crime, more than one-half still agreed that this is a benefit (59%).

When asked if there are any other benefits that they receive, about one in ten (9%) said yes, most often citing general positive quality of life (2%), promoting family time (2%), just having something to do (1%), advocating appreciation of the environment and nature (1%), positive health benefits (1%), and opportunities for social interactions (1%).

Across the three regions of Westchester County, residents' agreement with the benefit statements were relatively consistent, with two exceptions. Residents of the Northern region tended to be the most likely to agree that Westchester County parks, trails, recreation facilities, and services preserve open space and the environment (98% vs. 94%-95%), while those in the Southern region were the most likely to agree that they help reduce crime (65% vs. 53%-57%).

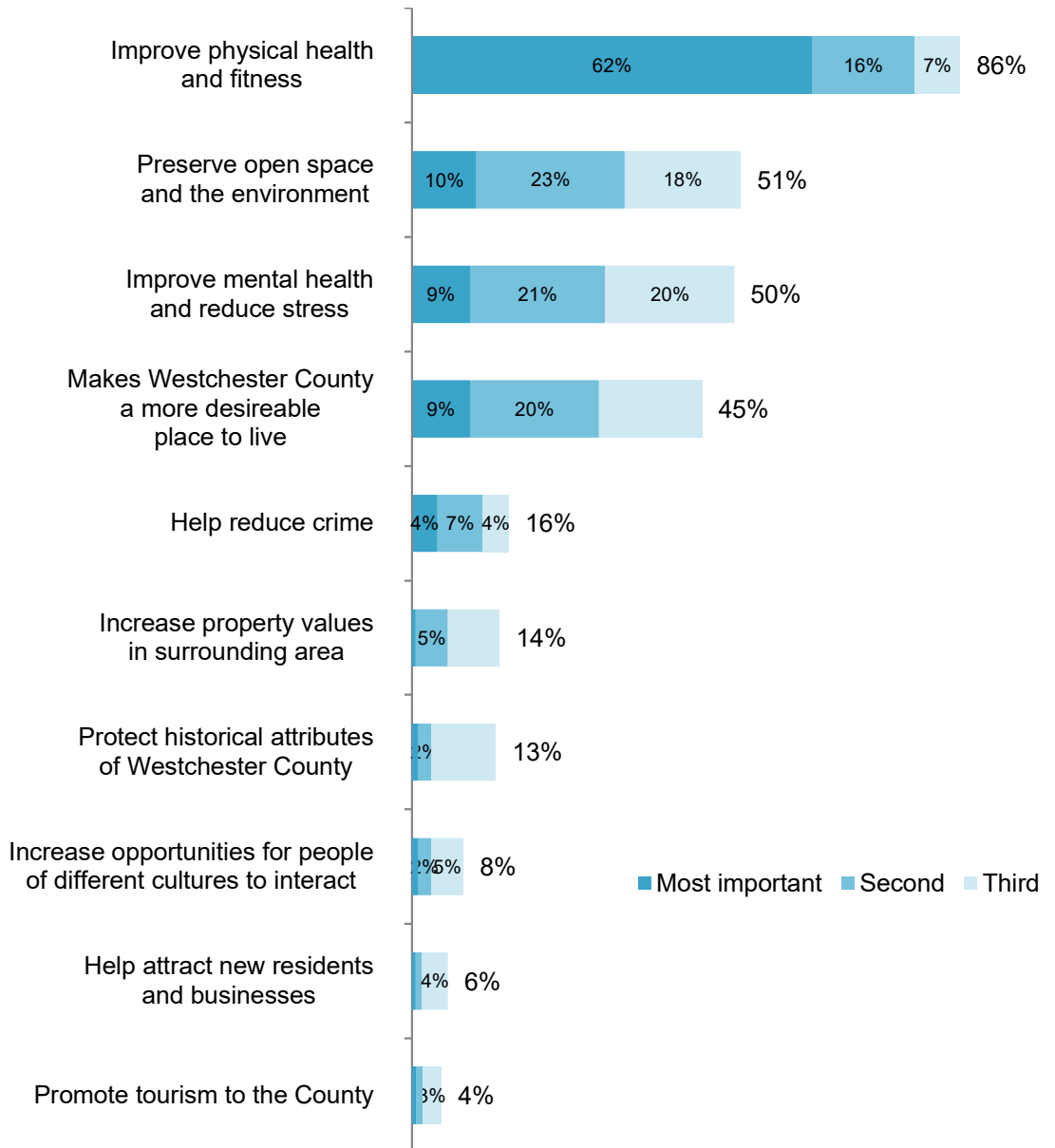
Most Important Benefits of Park and Recreation Facilities

From the list of 10 potential benefits provided by Westchester County parks, trails, recreation facilities and services, the residents surveyed were asked to select the three that are most important to them and members of their household.

Based on the sum of their top three choices, the most important benefit is improving physical health and fitness (86%). In fact, more than six in ten (62%) said this is the most important benefit.

About one-half selected the following as one of their top three choices:

- Preserving open space and the environment (51%),
- Improving mental health and reducing stress (50%), and
- Making Westchester County a more desirable place to live (45%).

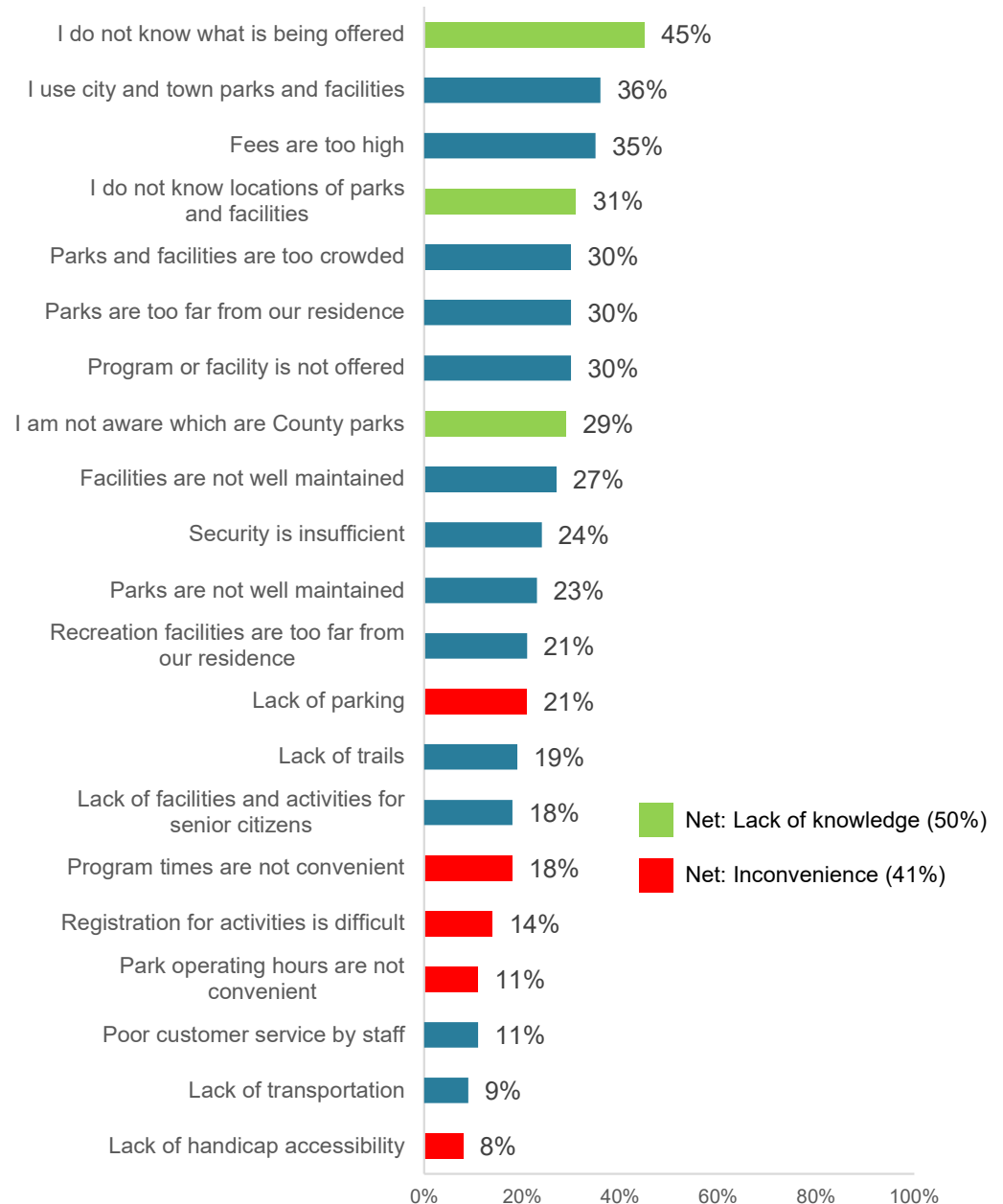

From a list of 21 potential reasons that might prevent them or members of their household from using parks, trails, recreation facilities, or programs of the Westchester County Department of Parks, Recreation and Conservation more often, the residents surveyed in 2022 most often indicated:

- They don't know what is being offered (45%),
- They use city and town parks and facilities (36%),
- The fees are too high (35%),
- They do not know the locations of parks and facilities (31%),
- Parks and facilities are too crowded (30%),
- Parks are too far from their residence (30%), and/or
- A program or facility is not offered (30%).

Looking at these reasons from a broader perspective, we can see that one-half of the residents surveyed (50%) selected responses related to a lack of knowledge, while four in ten selected reasons related to convenience issues, or lack thereof (41%).

While there are general similarities across the three regions of the County in terms of residents' reasons for not using Westchester County parks and facilities more often, a few differences emerged.

Specifically, those in the Central tended to be the most likely to select reasons related to lack of knowledge (56% vs. 44%-50%)

South County residents were more likely than those in the North and Central regions to select several reasons for not using Westchester County parks and facilities more often, including poor maintenance of the facilities (33% vs. 23%) and/or parks (28% vs. 19%), insufficient security (33% vs. 17%-19%), lack of facilities and activities for senior citizens (25% vs 14%), and/or poor customer service by staff (15% vs 8%-9%).

Central and South County residents were more likely than those in the North to say they use city and town parks and facilities (42% and 38% respectively vs. 29%).

When asked if there are any other reasons that prevent them from using the parks and facilities more often, 7% said yes, most often citing things out of the County's control such as a lack of personal time (1%), COVID (1%), and the respondent's personal health (1%), while a few (1%), however cited other park users not cleaning up after their dogs or having their dogs on a leash.

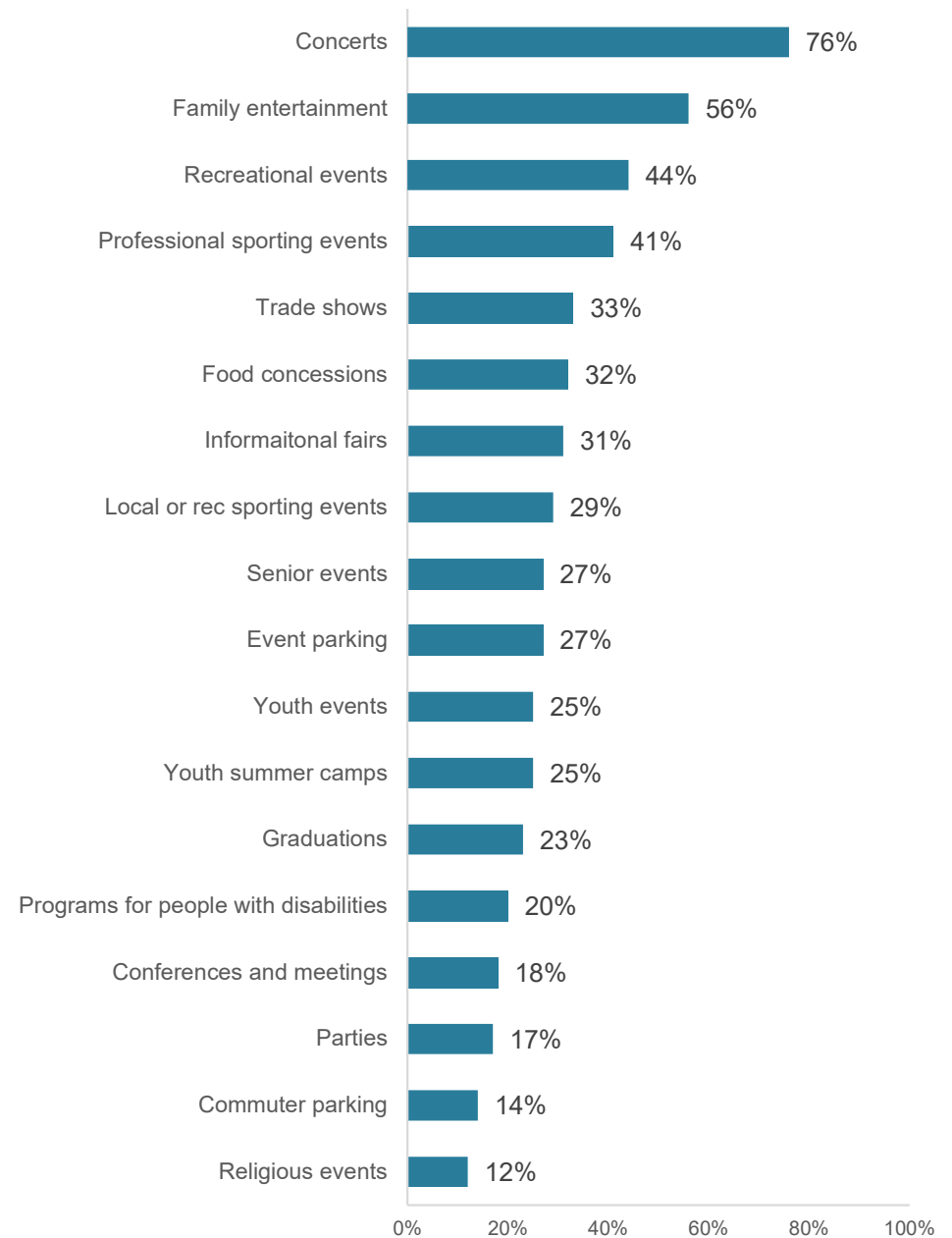

Desired Events/Services at Westchester County Center

For the past few years, Westchester County Parks has worked with local and state officials to transform the Westchester County Center into a field hospital utilized for administering COVID-19 vaccinations. Before the County Center can reopen at a date to be determined, they will begin the process of reimagining the facility for Westchester residents as a civic center for recreation and public interest events and commercial activities.

The residents surveyed in 2022 were asked which events or services at the Westchester County Center they would most like to see return or improved.

From a list of 18 possibilities, the residents selected concerts most often (76%), followed by family entertainment (56%), recreational events (44%), and professional sporting events (41%).

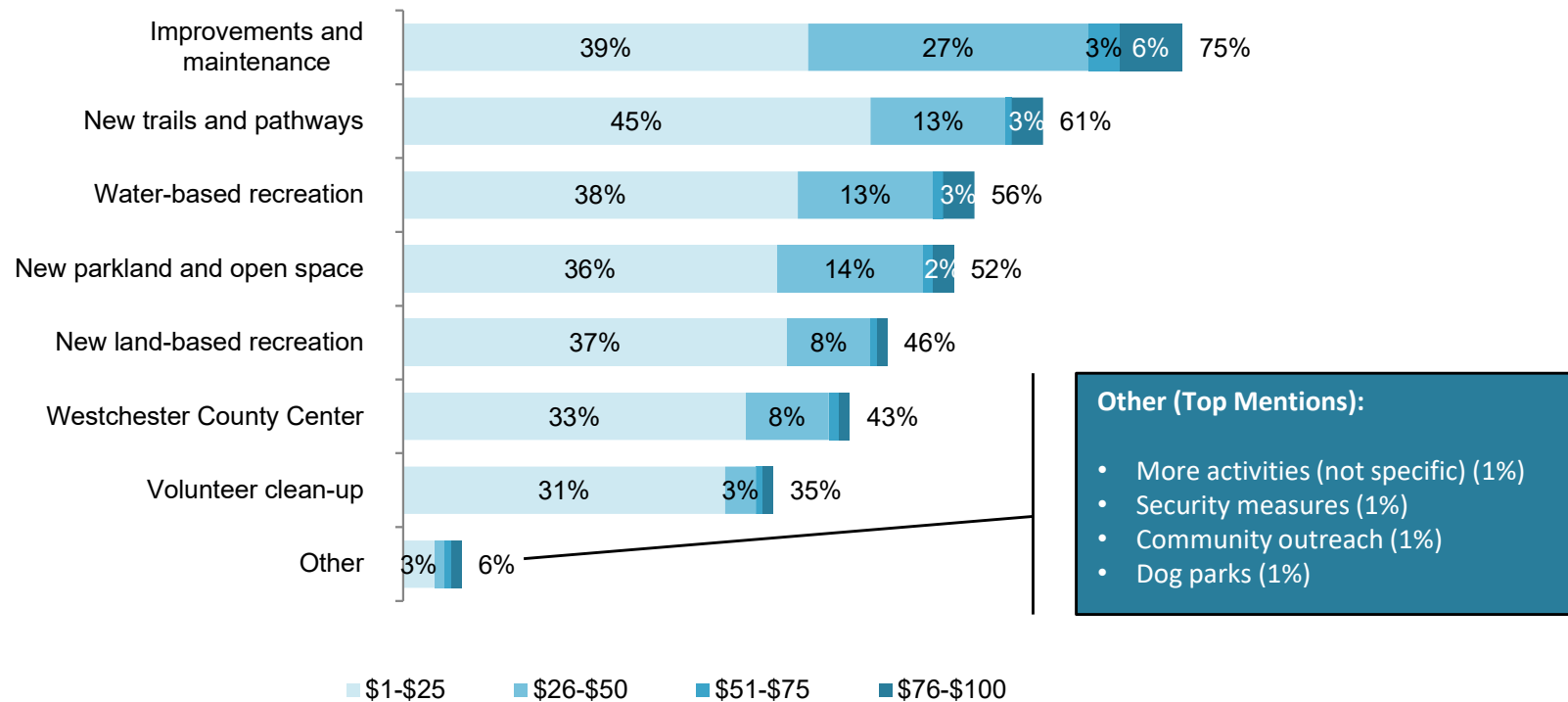

Investing in the Westchester County Park System

The County residents surveyed were asked to imagine they have been given \$100 to invest in the Westchester County Park System over seven possible categories, and to determine how much they would allocate to each category.

The residents were most likely to allocate funds to improvements and maintenance of existing Westchester County parks (75%), followed by new trails and pathways (61%), water-based recreation (56%) and/or new parkland and open space (52%).

Q18. Imagine you have been given \$100 to invest in the Westchester County Park System over 7 possible categories. How much of this \$100 would you allocate to each category?

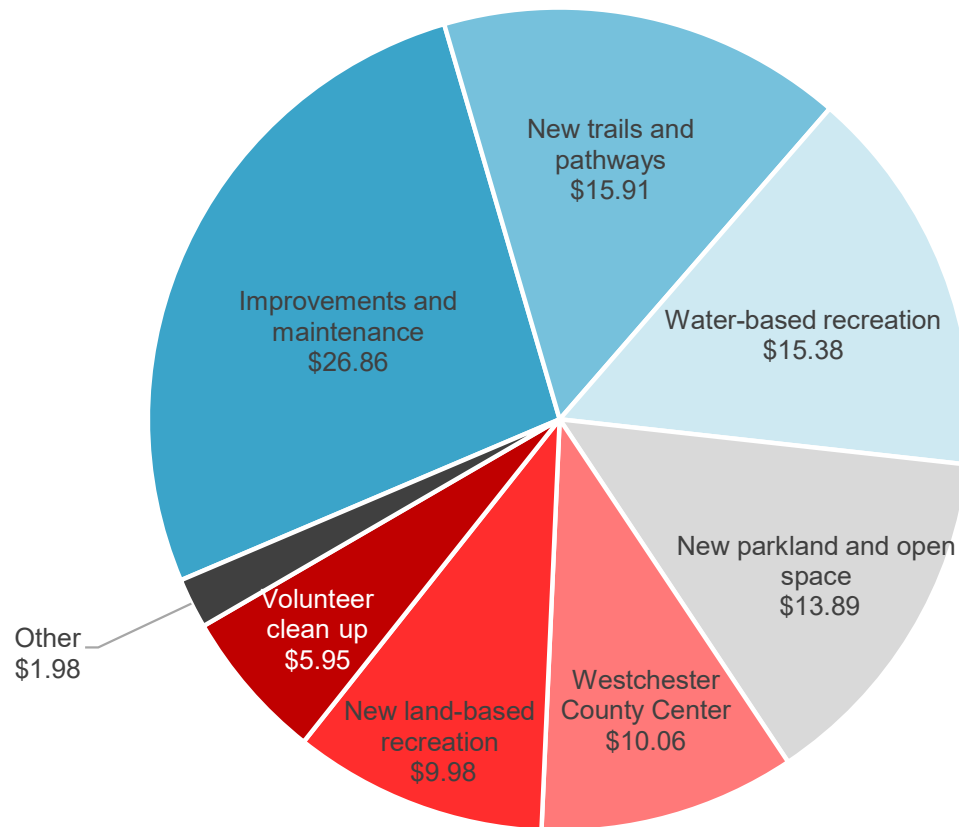

Investing in the Westchester County Park System (continued)

On average, these residents would allocate the largest sums to improvements and maintenance of existing Westchester County parks (\$26.86 out of \$100), followed by an almost even division of funds among Development of new trails and pathways, i.e., walking, hiking and biking trails, etc. (\$15.91), development of water-based recreation, i.e., swimming facilities, boating and fishing areas, beaches, etc. (\$15.38), and acquisition of new parkland and open space (\$13.89).

These residents would allocate an average of about 10% of the funds to reimagining Westchester County Center (\$10.06) and development of new land-based recreation, i.e., campgrounds, picnic areas, golf courses, ball fields, etc. (\$9.98).

Residents would invest the smallest level of funds in volunteer clean-up opportunities (\$5.95).

Compared to those in the Central and South regions, residents in Northern Westchester County tended to allocate the largest average amount to acquisition of new parkland and open space (\$16.74), while those in the Southern region tended allocated the largest amounts to development of new land-based recreation (\$11.57) and volunteer clean-up opportunities (\$7.83).

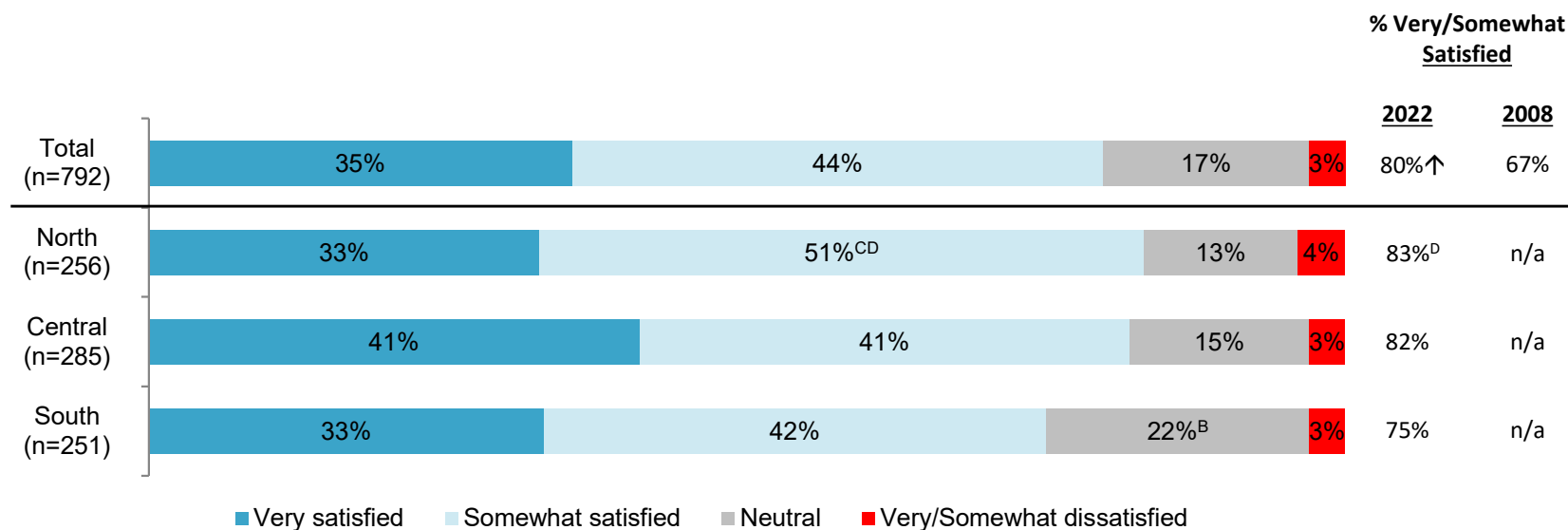

Satisfaction with Overall Value Received from Westchester County Department of Parks, Recreation and Conservation

When asked to rate their satisfaction with the overall value their household receives from Westchester County Department of Parks, Recreation, and Conservation, eight in ten residents surveyed in 2022 (80%) indicated they are very or somewhat satisfied (up from 67% in 2008). About one-third (35%) specifically said they are very satisfied.

By region, residents of Southern Westchester County tended to be the least likely to indicate they are very or somewhat satisfied (75%).

Effect of COVID-10 Pandemic on Use of Westchester County's Outdoor Parks and Recreation Facilities

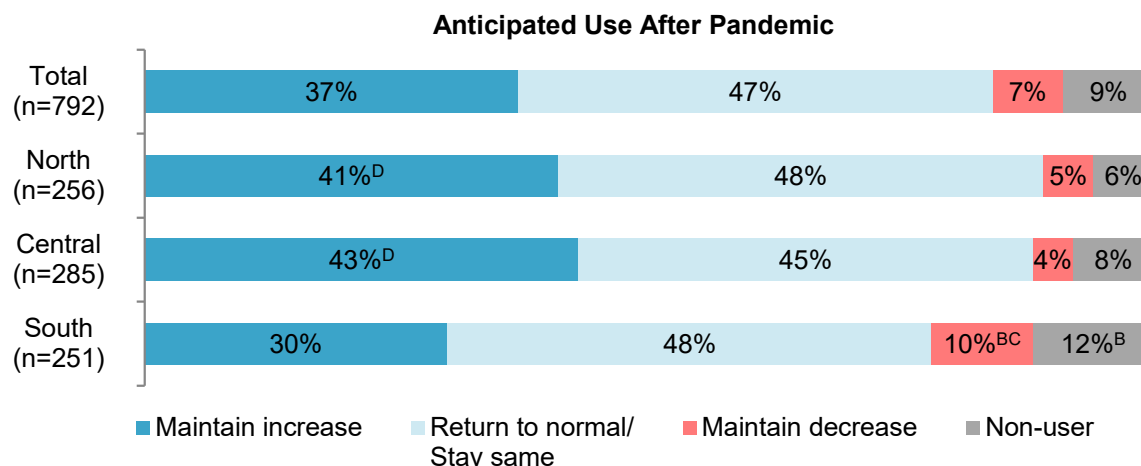
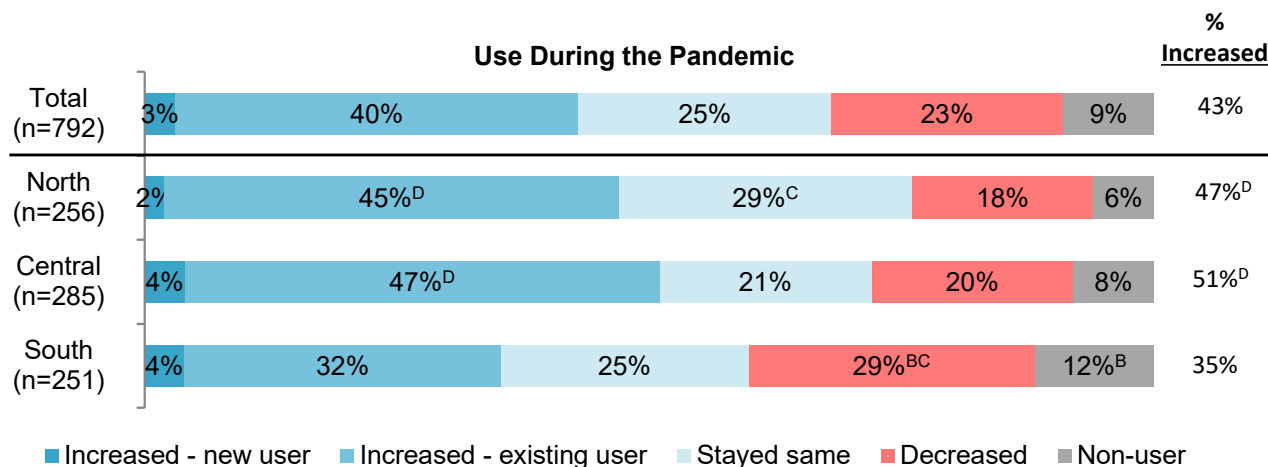
The residents surveyed in 2022 were asked whether their household's use of Westchester County's outdoor parks and recreation facilities increased, stayed the same or decreased in 2020 during the height of the COVID-19 pandemic, and if it increased, whether they had used these parks and recreation facilities prior to the pandemic.

Overall, 43% of County residents indicated their use of County parks and recreation facilities increased during this time, with 3% being new users. Close to one-fourth (23%), however, said their use decreased.

Residents of North and Central Westchester County were more likely than those in the South to have increased their use (47%-51% vs. 35%), while those in the South were more likely to have decreased their use (29% vs. 18%-20%).

More than one-third of the residents (37%) plan to maintain their increased use of Westchester County parks and recreation facilities, compared to only 7% who plan to maintain a decrease, for a net overall post-pandemic increase.

North and Central County residents are most likely to say they will maintain increased use (41%-43% vs. 30% of South County residents).
